against further exploration of the area.

I found some material on it back in 1985 or so and when the Mars observer was launched,

to be. I'm a chameleon. And that way you're not going to catch me. He doesn't know how to control

his emotions. Once he lets go, once he's gone over the edge, it's really hard to get him back.

And is his character in your mind a lot like Donnie L said? Yes. Very much so. He's playing with me.
