Now in 1919, 1920, they built an addition in the front

116

because this was very set back in the street.

The front part was added later.

So we're just trying to get the history of the building

Surgery please!

No, I was looking at, what's that, Ryan?

You're about playing with the drone.

What's that, Ryan? Ryan, you need me?
