Vicki Landrum has struggled to convince the government and the public that contact with extraterrestrials has left her scarred and riddled with disease.

It's not just a light in the sky or somebody thinks they saw something.

151

00:12:15,000 --> 00:12:20,000

A real serious case, you know they've seen something. It changes people's lives.

152

They're never the same afterwards if they've had a close encounter or if they've been injured.

153

Houston, 1980. They were driving on a deserted road. Betty Cash, Vicki Landrum and her 7-year-old grandson Colby.

They believe the forces of nature are ruled by the gods, break their laws, and the gods will retaliate.

197

Hawaiians believe ground that is sacred to the gods must be respected. For that reason, according to local beliefs, the Seven Seas Hotel should never have been built.

198

Native Hawaiian people have a great deal of respect for what westerners might consider superstitions.

199

00:18:02,000 --> 00:18:12,000

When Hurricane Iwa destroyed the Seven Seas Hotel in 1982, many Hawaiians believed that it was an act of vengeance by angry gods.

200

00:18:12,000 --> 00:18:17,000

During construction of the hotel, an ancient Hawaiian burial site was unearthed.

201

00:18:17,000 --> 00:18:22,000

Some natives believed the site would be cursed unless it was blessed by a holy man, a kahuna.

202

00:18:22,000 --> 00:18:27,000

But developers dismissed the practice as superstition, and construction continued.

203

00:18:28,000 --> 00:18:35,000

In Hawaii, there are just certain things that you have to do. When you build something, you have to have the land blessed.

204

00:18:35,000 --> 00:18:45,000

And according to all details, this was not blessed. When if you're excavating, you uncover bones, they have to be disposed of properly.

205

And apparently they were not disposed of properly here, so they were asking for trouble.

Once the hotel opened, the gods seemed to make their presence known.

207

The people that had stayed there saw dead bodies floating in the ocean. They had terrible, terrible odors in their rooms.

208

They had birds attack them in the dining room. A lot of the local people that had originally started to work there experienced many, many eerie things.

209

00:19:12,000 --> 00:19:19,000

And a lot of them quit working. Me, I worked one night. I was night shift, okay?

210

Then I was cutting my vegetables. Then I don't know from where that thing came. Rainbow color.

211

Spinning like that against the icebox. So I saw the ground funny.

212

I took that knife and I started cutting the shadow. I said, don't you ever bother me because I don't bother you.

213

Julie Coe was 14 when she and her mother moved into the hotel in 1977. They stayed for six months in room 13.

214

My mom would work late at night and so I'd be home by myself, do my homework and what all.

215

And they'd just play games with me all night long. The only way I got rid of them, an old local woman told me, she said they hate swearing.

216

She said they absolutely hate swearing. And one night I had just had it. I couldn't sleep. I couldn't read.

217

00:20:08,000 --> 00:20:18,000

They were just making too much racket. They were making me very uncomfortable and I got up on my bed and screamed every four letter word I could think of in every combination I could think of.

218
