Kecksburg used to be just like a lot of other small villages in western Pennsylvania.

Just as the town is divided, so too are experts who have researched what really happened in Kecksburg.

Planetary expert Robert Young believes that some citizens may have perpetrated a hoax.

He claims the UFO was merely a meteor known to have passed over Ontario in several northern states that evening.

Virtually all of the accounts can be explained by people having looked toward and seeing the Ontario meteor.

How about the accounts though of the military that turned out in large numbers,

It was about 10 to 12 foot at the base, 12 foot tall. It looked like a chocolate drop.

When my friend told me that every question I ever had about UFOs was under that canvas, I was mystified.

Since that time, Stone has repeatedly attempted to obtain information from the government regarding that object.

Each time, the government's response has been the same.

We may neither confirm nor deny the existence or non-existence of any information that all involved

the recovery of unknowns.

Kecksburg remains a town divided. The only thing on which believers and non-believers can agree is that all they want to know once and for all is what really happened on December 9th, 1965.

What would you like to see happen next?

I would like to see the public to know the truth, regardless of what the object was, and what really occurred.

The children race home before dark, where they stand guard against what they believe are demons.

170

Since the Malones moved to this Carrollton home two years ago, things haven't improved.

171

They fear any home they live in will become a battleground for something bizarre, something evil.

172

00:14:23,000 --> 00:14:26,000

I definitely think it's the devil.

173

00:14:26,000 --> 00:14:30,000

I feel like that I can't protect my children from it.

174

00:14:30,000 --> 00:14:34,000

It's after this, you're one of us in the family, all of us.

175

I've wondered a lot of times if this evil spirit was working through our safe child, our safe

daughter.

176

Sometimes people turn to paranormal explanations because there is an explanation that they don't want to face.

177

They claim that terrorists started the day their youngest daughter was born, but that it's unrelated to her medical condition.

The family believes her brain damage, asthma and kidney transplant have nothing to do with the evil force that plagues them daily.

It's attacked my brother at one time. It's had him up against the wall of Chokin Hill. He was swinging in midair. Nothing was there. There was no arms, nothing.

180

Where is it at? You can't see it.

181

I opened my eyes and it was a thing that was standing over me. It was real big and it was black. I couldn't move.

I woke up and I saw something walking through the hall. It looked like it didn't have no head in there.

All these people can't be seen and hear the same thing, so therefore it's not imagination, it can't be.

Part of the motive of a family is to hang together. And since their motive is to hang together, they would not necessarily say,

oh, don't believe that, that's not likely because that in a certain sense might threaten the togetherness, the sense of togetherness of the family.

Everybody that would experience it wouldn't know that it's real.

The Malone's daughter-in-law has recorded each paranormal encounter in her diary. Her entries tell the story of a family in crisis,

The family in Georgia is being plagued by inhuman evil spirits that are affecting their lives on every possible level.

They have fled from house to house to try to escape this evil, but you cannot escape it.

It must be dealt with, it must be documented, and it must be gotten rid of through spiritual means.

In 1990, the Malones contacted Ed and Lorraine Warren, world renowned for their work with victims of what they feel is demon possession.

193

First, they studied the family's claims and their psychiatric history. Only then did the Warrens agree to conduct a face-to-face investigation.

194

A figure, a dark black figure about four feet.

195

I saw balls of light continuously, probably the size of a tennis ball.

196

I had heard wrappings there, wrappings right underneath my feet.

197

00:17:05,000 --> 00:17:15,000

This audio cassette is the only record of the night the Warrens were working with the Malones and claim a jar of pennies levitated and smashed into a researcher.

198

And then a family member.

199

00:17:17,000 --> 00:17:22,000

The Margers and the Saints command you to reveal your identity.

200

00:17:22,000 --> 00:17:27,000

Give us a sign that you want the Malones out of this house.

201

00:17:31,000 --> 00:17:38,000

The pennies picked themselves up, jar and all, had to move out of the room, come through the door.

202

00:17:38,000 --> 00:17:47,000

It first clipped Joe hard on the shoulder and then went and got the sun right in the face.

203

00:17:47,000 --> 00:17:53,000

And I was just terrified and I ran out of the house. I was crying, my nose was bleeding.

204

00:17:53,000 --> 00:18:04,000

It was so heavy and so humid that night and yet as soon as you started to provoke in that house, we were getting that psychic cold.

205

It was kind of like in waves, like as if there was a fan blowing from a freezer.

206

I could feel it on my ankles for us. There was true psychic cold.

207

The women were shouting and it was everybody's running around confused.

Eventually the phenomena ebbed and things calmed down but everybody slept in the living room that night.

No, I'm not crazy. No, I'm not on drugs. No, I don't drink period.

It's not a fraud. It's not a hoax. It's not a psychologically disturbed family.

You want to call it devil's demons? I don't care. But there are things surrounding this family that are so terrifying that the average person looking at us right now could not in any way accept unless they were there and living it.

After the Warrens first visit, family life seemed to return to normal but those were rare moments of peace.

Soon the hauntings returned and then got worse. Desperate for relief from their nightmare, the Malones turned again to the Warrens and this time the Warrens asked sightings to document their work with the Malone family.

Blight's words had started appearing in the living room. And my wife she screamed and she had got something better on the neck.
