Clinical psychologist Ralph Underwager believes there is nothing paranormal about Trevillo's heinous acts.

No, I would never deny that Satan exists. What I would deny, most vehemently, is that he has any power whatsoever to control or to direct or to possess human beings.

Something's going on here.

Husband and wife counseling team Dr. Walter and Linda Young are the leading pioneers in treating victims of ritual abuse.

Linda and I work in this field together and obviously we have to deal with what it's like day in and day out to work with people who've been traumatized to this extent.

And I would have to say that when we're talking about issues of ritual abuse, where patients are talking about murder,

it really takes its toll because of the sense of the unbelievable ability of how they survived it.

I've heard of babies being killed, people delivering babies prematurely, or full term babies that have been sacrificed.

And satanic rituals where people are married to Satan and impregnated by someone or a group of people.

Again, no one wants to hear that. It's too horrific for the population.

Barbara Jackson is a scientist with a PhD in biochemistry and a former instructor at Harvard Medical School.

She claims to be a survivor of satanic ritual abuse.

For Barbara, memories of childhood torture didn't surface until she was an adult.

Her stories of abuse follow a pattern exactly like those of other survivors Barbara has never met.

Coming forward has taken immense personal courage.

People would start arriving and they would have robes.

And I would just be brought into the basement and the basement is divided into two halves.

One half is open. That's often where the table that the child or the animal would be put on to be hurt.

I remember one time being put on this table that they were using and they would hurt me with a metal crucifix.

What is evil for you?

Evil feels to me like a force.

92

Barbara, many people who might be very sympathetic with you would simply not believe you.

How could anything this horrendous occur?

We already know that things this horrendous have occurred routinely throughout the world.

And those victims remain afraid of retaliation by their abusers and ridicule by a skeptical public.

But despite their fears, they have spoken out in the hope that they may help others avoid the same fate.

herself has endured.

Why are you telling this story?

113

It needs to be stopped. Somebody needs to say it.

I figure the worst they can do is kill me. They've certainly tortured me an awful lot and dying doesn't frighten me anymore.

Did you ever kill?

116

Yes, I had to kill a number of people when I was young.

117

How did you do that?

118

I had to put knives in their stomach. Many times they would put their hand around my hand and they would put the knife in and let me know that this was my fault.

Was someone or something always killed?

Almost always.

What is evil to you?

The more survivors I talked to, the more people are reporting they witnessed that entity in their memory.

An evil entity, an evil force.

Survivors believe they've experienced that force first hand.

But while there is a frightening similarity to stories from people who've never met, an argument can be made for the persuasive power of suggestion.

Is Satanic ritual abuse real or is it false memory produced by therapists?

128

To have recovered repressed memories, to have flashbacks, to events that they never knew about before and had no memories of before, that I say yes.

Indubitably is a false memory and that those events never occurred.

130

I think we're training more and more therapists to know how to treat these people.

131

And I think more and more people really are willing to take that challenge to go back in time and feel the pain.

132

Do you feel your life was ruined by this?

133

No, I feel my life path was permanently altered.

But it's possible to live through it, transcend it, live with the after effects and interact very richly with life, to reconnect with people, with spirituality, with all the things that have meaning because they can't take that away.

Joining me now is Gretchen Passantino, who has been researching the occult and Satanic ritual abuse for more than 20 years.

Gretchen, welcome to Sightings.

Thank you very much, Tim.

As you know, I had an opportunity to speak with people who believed themselves to be survivors of ritual abuse.

140

Their stories were compelling. They certainly believed what they had been through, but you're not convinced. Why?

141

Well, Tim, I'm very glad that you brought out that these adult survivors believe what they're saying, but I believe that a much more reasonable explanation that fits the evidence better is that they have been given the wrong tools for knowing the truth and knowing the past through directive, contaminated therapy that tells them that images in their minds are actually memories of things that have actually happened to them.

So you think it's all power of suggestion then on behalf of the therapists who are trying to help them?

I think it's more complex than simply power of suggestion. They come up with things that they are told are repressed memories and yet they actually are not.

What would be convincing evidence?

Well, I think you would have to take it on a case-by-case basis. I'm not saying that there are not evil people who sometimes do very evil atrocities to other people, but what I'm saying is unsubstantiated, directive, contaminated, therapeutic testimony is not the best way to find reality.

What if they're right, Gretchen, and you're wrong?

If the sensationalism of the Satanic ritual abuse scare is true, then logic doesn't matter, evidence doesn't matter, investigation doesn't matter, the psychotherapists have become the priests, the new religion.

I'm not willing to accept that. I don't think it's reasonable.

And tonight, we follow Lloyd into the Mock home to watch the process step by step.

In this quiet, comfortable summer of the Los Angeles, Anita Mock, her daughter and her cousin have all reported encounters with two distinct entities in their home.

158

One, a ghostly apparition dressed in white with beady glowing eyes.

159

00:16:09,000 --> 00:16:12,000

The other, a mischievous poltergeist in the back bedroom.

160

00:16:13,000 --> 00:16:20,000

My little girl's hysterical and I can't do anything. I feel so weak, so helpless, and I don't know what to do.

161

00:16:21,000 --> 00:16:26,000

After my initial visit, Lloyd Auerbach brought his team into the Mock home.

162

00:16:26,000 --> 00:16:31,000

While he took magnetic field readings, therapist Karen Hussing tested the family.

163

00:16:34,000 --> 00:16:38,000

We literally have things happening that don't always mesh together.

164

00:16:38,000 --> 00:16:44,000

Normally, when you see an apparition in a case, you don't normally also have physical object movements.

165

00:16:44,000 --> 00:16:51,000

So this is kind of a mixed-bag case that we'll have to take a little closer look at through process of interviewing and checking out the house itself.

166

Where was it when you heard the sound? Was it flipped over like that?

167

00:16:55,000 --> 00:16:56,000

It flipped like this.

168

00:16:56,000 --> 00:16:58,000

Okay, so really it wasn't easy to get at anyway.

169

No, uh-huh.

170

I'm getting an anomaly and we are correlating these anomalies to the spots that people are sensing or seeing,

171

apparition or haunting phenomena, hearing things.

172

What could the family be experiencing?

173

00:17:13,000 --> 00:17:20,000

We found that the house did have a history of domestic violence and untimely death prior to the time the Mocks moved in.

174

00:17:20,000 --> 00:17:27,000

Before turning their case over to sightings, Anita had asked a priest to bless the home, but the entity remained.

175

00:17:29,000 --> 00:17:36,000

He blessed the house, he went around here really quick, and when he was done all he told me was that I need to go back to church.

176

00:17:36,000 --> 00:17:42,000

In addition to our box team, we asked psychic Sylvia Brown to record her impressions of the house.

177

00:17:42,000 --> 00:17:45,000

Sylvia had strong, unsettling feelings.

178

00:17:45,000 --> 00:17:47,000

See, this room also has Anita's some activity.

179

00:17:47,000 --> 00:18:01,000

When I first came into the house, I felt this tremendous amount of violence, physical violence, glass cracking, noise, and there's a murder, a killing, blood.

180

Somebody's face slashed.

181

00:18:04,000 --> 00:18:10,000

We have a case here of layer upon layer of poltergeist haunting.

182

00:18:10,000 --> 00:18:13,000

I'm not sure I would want to stay here.

183

00:18:13,000 --> 00:18:17,000

But there are people living here and they don't want to be forced out.

184

00:18:17,000 --> 00:18:22,000

In addition to the poltergeist activity, they're still plagued by encounters with the apparition in white.

185

00:18:22,000 --> 00:18:27,000

It was wearing white and it was peeking around the door and it had like its hands on the door.

186

00:18:27,000 --> 00:18:30,000

She grabbed my daughter because she was afraid to look up at me.

187

00:18:30,000 --> 00:18:35,000

She was afraid because it looked solid. She was afraid it was going to come out and get her.

188

00:18:35,000 --> 00:18:38,000

This is the very spot where Heather said she saw the ghost.

189

00:18:38,000 --> 00:18:42,000

So normally what this house is reading is one milligoules normally.

190

00:18:42,000 --> 00:18:52,000

But this is going up as high as two and a half milligoules in three and that's double or almost triple what you're experiencing the rest of the house.

191

White magnetometer measures the level of electromagnetic energy in milligoules.

192

Do the unusually high magnetometer readings he's getting here explain why apparitions, poltergeist, slamming doors and spinning clocks have all been reported in the house?

193

Or does an answer lie in the minds of the family?

194

In a state of deep relaxation, Heather Wyeda recalls the apparition under hypnosis.

195

This entity that you have seen in the house would like to invite him to join you so that we can communicate.

196

I think he's here.

197

00:19:26,000 --> 00:19:29,000

Is there something that he wishes to communicate?

198

00:19:29,000 --> 00:19:33,000

That he's not trying to hurt me or my family.

199

00:19:33,000 --> 00:19:35,000

Does he know how he died?

200

00:19:35,000 --> 00:19:38,000

He said he doesn't like to talk about it.

201

00:19:38,000 --> 00:19:44,000

Is there anything else that he did that he could tell us about?

202

00:19:44,000 --> 00:19:47,000

He said he's sorry for hurting Amanda when he tried to pick her up.

203

00:19:47,000 --> 00:19:51,000

We just had a hypnosis session. I thought to come in here and check the reading which we were getting in.

204

00:19:51,000 --> 00:19:55,000

And most of the house reads between one and one point five milligas which is what we're now reading here in this spot.

205

I mean before the hypnosis session I was reading between two and two point five.

206

It may be a coincidence but actually it's very interesting to me that we have resolved the situation.

207

The ghosts supposedly go on the way and there's no longer a high reading.

208

Since our first report on the Garden Grove haunting another viewer called the sightings hotline with an important new lead.

209
