But one of the problems we face is that it's very difficult to analyze a one-time event.

Ufologists are looking for UFOs that appear again and again and offer a chance for closer

examination.

Just such a series of UFO encounters is occurring in the skies above Pennsylvania.

16

A local resident sent us his startling footage.

17

The first reported sighting occurred in 1991 in Newton Township, just north of Scranton.

18

Since then, dozens of people, including state and local police, have witnessed an unexplained

19

show of lights.

20

00:01:39,920 --> 00:01:42,640

The first home video was shot by Gary Steyer.

21

He started monitoring the skies after his daughter, Kristi, reported a bizarre encounter

22

with the UFO.

23

00:01:49,160 --> 00:01:52,720

I at first thought it was another car.

24

00:01:52,840 --> 00:01:56,640

But I looked out towards the back of me and I noticed there was no car in the back of

me.

26

00:01:57,640 --> 00:02:00,360

I was adjusting the mirror and I noticed an object in the sky.

27

It was flying behind my car and I kept watching it in my rear view mirror and eventually it

went over to where I could see it looking out the window.

29

It kept following me, driving down the road.

And then I made a right hand turn to come up onto the road coming up towards my house

and this object made a right hand turn.

By this point I was getting really scared.

She drove into the driveway, ran up to the front door, came flying in the house and

And then when she told me it was above her car, I didn't know what she was talking about.

Since Kristi had been the only one to experience the light phenomenon, the Steyer's thought

But a few months later, the lights returned and this time the extraterrestrial display

39

was witnessed by more than just one person.

40

While driving home on January 8th, Gary and his wife Nadia saw unusual lights hovering

41

in the distance near their house.

42

00:02:58,780 --> 00:03:01,800

They rushed home and Gary got out his video camera.

43

00:03:01,800 --> 00:03:05,200

This time he was able to get the UFO on tape.

44

It was feeling great excitement because these things were happening right before your eyes.

45

You didn't know really what these lights were, what was happening.

46

00:03:17,120 --> 00:03:20,040

It was like an adventure.

47

Being a respected school teacher, Gary Steyer was hesitant to call the authorities, fearing

48

public ridicule.

49

But when the lights continued hovering for several hours, he finally decided to alert

50

the police.

51

I have one emergency.

52

00:03:33,360 --> 00:03:37,200

You want to report what?

53

00:03:37,200 --> 00:03:42,920

And within a matter of minutes, Officer Cali arrived along with three state policemen.

54

And as I taped, they stood alongside of me with their handheld radios in my front yard.

55

00:03:48,960 --> 00:03:52,720

The dispatcher told me he received a call from a resident in the community that there

56

was a strange object in the air above his house.

57

00:03:56,800 --> 00:04:01,760

When he initially called me, he didn't want to give me anything but his street address.

58

He didn't want to give me his full name or phone number because he didn't want to be

59

associated with something that sounded this bizarre.

60

I didn't believe it initially when I received the call that I would do anything of substance

61

to that I would see.

62

I immediately panic saying, my police vehicle.

63

I looked up in the air and I saw four or five bright objects up in the air.

64

There's one right alongside of him.

65

There's one above the three towers.

66

Another one just blasted.

67

Officer Cali called into his dispatcher and asked him to check with the local airport

68

tower to see if they were picking up anything on radar.

69

00:04:37,480 --> 00:04:38,480

Lights.

70

00:04:38,480 --> 00:04:39,480

All right.

71

00:04:39,480 --> 00:04:40,480

Well, let me look.

72

00:04:41,480 --> 00:04:44,000

It was one of those real crystal clear nights.

73

00:04:44,000 --> 00:04:46,000

There wasn't a cloud in the sky.

74

00:04:46,000 --> 00:04:50,280

We looked out the window over towards where he was talking about and sure enough, there

75

00:04:50,280 --> 00:04:51,840

were some lights out there.

76

00:04:51,840 --> 00:04:55,600

According to local sources, there were no commercial or military aircraft in the area

77

00:04:55,600 --> 00:04:58,520

that night and nothing was picked up on radar.

78

00:04:58,520 --> 00:05:03,160

But despite this, half a dozen witnesses reported seeing a UFO.

79

00:05:03,160 --> 00:05:11,040

They had no aircraft in the area of the triple towers and that no airplanes were supposed

80

00:05:11,040 --> 00:05:14,240

to be in that area and nothing was picked up on radar.

81

00:05:14,240 --> 00:05:19,120

I felt that there was possibly a problem with the radar system.

82

00:05:19,120 --> 00:05:23,360

Surely thereafter, he contacted me back and said that they checked it again and there's

83

00:05:23,360 --> 00:05:25,440

nothing up there.

84

00:05:25,440 --> 00:05:29,840

The lights appear to be most active over this area, Bald Mountain.

85

00:05:29,840 --> 00:05:34,360

Pam Zekofsky is a local newspaper reporter who first broke the UFO story.

86

00:05:34,360 --> 00:05:39,360

She was an impartial observer until she hiked to the top of Bald Mountain with UFO investigator

87

00:05:39,360 --> 00:05:41,000

Irene MacDonald.

88

00:05:41,000 --> 00:05:45,160

Near the summit, the two women had a terrifying encounter.

89

00:05:45,160 --> 00:05:50,720

We were merely poking around, actually trying to see where Gary Steyer's house was from

90

00:05:50,720 --> 00:05:54,520

the top of the mountain.

91

00:05:54,520 --> 00:06:02,360

Two men in a pickup truck pulled up, drove up the access road and they both got out.

92

00:06:02,360 --> 00:06:05,640

One was older and one was younger.

93

00:06:05,640 --> 00:06:10,200

They both had guns and they were incredibly angry.

94

00:06:10,200 --> 00:06:16,240

They said, you're trespassing, you know you're trespassing, what are you doing up here?

95

00:06:16,240 --> 00:06:18,920

I said we were just taking a walk in the winter.

96

00:06:18,920 --> 00:06:20,120

I wasn't going to say.

97

00:06:20,120 --> 00:06:25,200

We were up there looking for evidence of UFOs.

98

00:06:25,200 --> 00:06:33,400

When I saw their intense anger and their guns, I knew that in 30 seconds or a minute I either

99

would be alive or I wouldn't be.

100

00:06:37,760 --> 00:06:45,160

We agreed to leave, but we had only been up there probably maybe five minutes at the most.

101

And what's unusual is the fact that almost everybody at one time or another in this area

102

00:06:50,920 --> 00:06:59,280

has climbed that mountain for exercise or recreation and never have been threatened with a gun.

103

00:06:59,280 --> 00:07:04,280

Pam Zekoski never saw the two men again and believes they were not local.

104

00:07:04,280 --> 00:07:08,920

She ran a search on their license plate number, but that has only deepened the mystery.

105

00:07:08,920 --> 00:07:13,480

The plate number does not exist in any Pennsylvania motor vehicle record.

106

00:07:13,480 --> 00:07:16,080

The identity of the two men is still unknown.

107

00:07:16,080 --> 00:07:20,600

Could their appearance be somehow related to the unexplained lights in the area?

108

00:07:20,600 --> 00:07:26,040

After the incident on Bald Mountain, the UFO activity has only increased and more witnesses

109

00:07:26,040 --> 00:07:27,120

have come forward.

110

00:07:27,120 --> 00:07:34,400

It was just about dusk and as we were there by the power lines, all of a sudden these

111

00:07:34,400 --> 00:07:36,920

objects started coming up out of the treetops.

112

00:07:36,920 --> 00:07:39,320

They were just everywhere, seeing wherever we turned.

113

00:07:39,320 --> 00:07:40,800

There was another one.

114

00:07:40,800 --> 00:07:44,160

I just remembered not hearing a sound.

115

00:07:44,160 --> 00:07:48,160

But not everyone in the area believes the lights are UFOs.

116

00:07:48,160 --> 00:07:53,480

Karen and Bob Siemens own the airport in Factoryville, about 10 miles south of Bald Mountain.

117

00:07:53,480 --> 00:07:57,480

They believe people are simply sighting their newly installed beacon.

118

00:07:57,480 --> 00:08:01,920

I think because we had put a new beacon up and people in the area were not used to seeing

119

00:08:01,920 --> 00:08:06,360

the light, I really think it's just too much of a coincidence.

120

00:08:06,360 --> 00:08:10,960

Investigating the Siemens theory further, we took Gary Steyer's footage and overlaid

121

00:08:10,960 --> 00:08:14,520

footage of the airport beacon taken from the same angle.

122

00:08:14,520 --> 00:08:18,760

Using the grid system, it appears impossible for the beacon and the lights to be one and

123

00:08:18,760 --> 00:08:20,000

the same.

124

00:08:20,000 --> 00:08:23,160

We also took the videotape to ufologist Jeff Sanyo.

125

00:08:23,160 --> 00:08:27,760

After careful analysis, Sanyo has concluded that the lights are not conventional aircraft,

126

00:08:27,760 --> 00:08:32,320

nor are they a hoax and they're definitely not emanating from the beacon.

127

00:08:32,320 --> 00:08:35,280

My impression of this tape is that it certainly wasn't faked.

128

00:08:35,280 --> 00:08:40,880

After all of the unusual lights are moving laterally and so an airport beacon light doesn't

129

00:08:40,880 --> 00:08:42,120

move laterally.

130

00:08:42,120 --> 00:08:48,520

So that couldn't explain any of the five interesting points that I found on this tape.

131

00:08:48,520 --> 00:08:53,680

As if in response to increased interest in the lights, the UFO activity has subsided in

132

00:08:53,680 --> 00:08:54,680

recent months.

133

00:08:54,680 --> 00:09:00,200

But the people of Newton Township keep their eyes and cam corners pointed to the sky, anticipating

134

00:09:00,200 --> 00:09:03,720

the return of what some believe is an alien spacecraft.

135

00:09:03,720 --> 00:09:10,400

All I know is that we taped some unusual lights and objects in the sky.

136

00:09:10,400 --> 00:09:16,280

The night of January 8th did happen and I wasn't the only person that saw these things.

137

00:09:16,280 --> 00:09:20,840

There were hundreds of other people who had similar experiences, but they didn't have

138

00:09:20,840 --> 00:09:23,480

video cameras in their hands.

139

00:09:23,480 --> 00:09:29,760

And all I can say about the tape is that it speaks for itself.

140

00:09:29,760 --> 00:09:32,600

Right now, the skies near Scranton are quiet.

141

00:09:32,600 --> 00:09:36,680

However, local residents say that the UFOs come in cycles and they're anticipating a

142

new wave of UFO encounters in coming months.

143

Local police are ready to respond to any UFO calls that come in and are continuing to investigate

144

00:09:45,160 --> 00:09:49,640

reports of the mysterious men who have yet to be identified.

145

Coming up next.

When one of our viewers called to report bizarre ghost activity in her house, our first step

152

was to look into the history of the house and we did find that it had been a place of misery

153

and torment.

154

00:10:25,180 --> 00:10:30,080

The evil began in 1984 in a small town in Central Maryland.

155

00:10:30,080 --> 00:10:33,360

It's the kind of town that seems to promise the American dream.

156

00:10:33,360 --> 00:10:38,400

But two brothers were living a nightmare in one house in this quiet town.

157

00:10:38,400 --> 00:10:41,200

For a long time, it was their secret.

158

00:10:41,200 --> 00:10:46,040

But the day the boys, age four and six, told their mother, she told the police.

159

00:10:46,040 --> 00:10:51,200

What happened in this house to those two children is an absolute nightmare.

160

00:10:51,200 --> 00:10:54,480

The children were raped and molested repeatedly.

161

00:10:54,480 --> 00:11:00,160

They weren't safe because of the danger they lived within and that danger lied in their

162

00:11:00,160 --> 00:11:01,160

own father.

163

00:11:01,160 --> 00:11:03,360

He was convicted of sexual child abuse.

164

00:11:03,360 --> 00:11:06,240

But the boys insisted they were not the only victims.

165

00:11:06,240 --> 00:11:09,040

They described the brutal rape and murder of an infant.

166

00:11:09,040 --> 00:11:14,400

I don't think it's far-fetched to believe that a baby could be stabbed repeatedly, dismembered

167

00:11:14,400 --> 00:11:19,600

and then decapitated and then literally tossed into a creek.

168

00:11:19,600 --> 00:11:23,760

And of course that's what we believe happened in this particular circumstance.

169

00:11:23,760 --> 00:11:26,280

The police found no proof of murder.

170

00:11:26,280 --> 00:11:29,560

The father served just 18 months in prison.

171

00:11:29,560 --> 00:11:33,880

The house, with its monstrous memories, was sold to another family.

172

00:11:33,880 --> 00:11:38,600

Just six weeks after moving in, the new owner died suddenly, leaving his wife and three

173

00:11:38,600 --> 00:11:43,800

daughters alone in the house they now believe is haunted by an entity they call the Beast.

174

00:11:43,800 --> 00:11:49,040

This Beast has molested, raped, choked.

175

00:11:49,040 --> 00:11:50,040

He's touched.

176

00:11:50,040 --> 00:11:51,040

He's punched.

177

00:11:51,040 --> 00:11:52,040

He's scratched.

178

00:11:52,040 --> 00:11:55,240

And I just feel like it's getting stronger.

179

00:11:55,240 --> 00:12:00,440

The first time something had happened to me, I was laying in my bed and I woke up for

180

00:12:00,440 --> 00:12:02,320

no reason.

181

00:12:02,320 --> 00:12:06,440

And I heard this breathing and I could feel it in my ear.

182

00:12:06,440 --> 00:12:15,720

It was like, he said in a rude, deep voice, he was like, make love to me.

183

00:12:15,720 --> 00:12:20,200

It was pinching my breast, very hard.

184

00:12:20,200 --> 00:12:22,920

And it just squeezed me on my behind.

185

00:12:22,920 --> 00:12:26,440

It was like I was being sexually assaulted.

186

00:12:26,440 --> 00:12:30,880

It was taking itself and entering into my body.

187

00:12:30,880 --> 00:12:34,520

The family fled the house and called sightings for help.

188

00:12:34,520 --> 00:12:39,680

They sent this video, a record of the night the so-called Beast scratched the 13-year-old

189

00:12:39,680 --> 00:12:40,680

daughter.

190

00:12:40,680 --> 00:12:44,920

First he scratched me on the side of my face and it hurt to bed.

191

00:12:44,920 --> 00:12:48,440

Then he scratched me on this side of my face and it actually broke the skin down here and

192

00:12:48,440 --> 00:12:50,520

it was bleeding.

193

00:12:50,520 --> 00:12:52,840

And I was just crying hysterical.

194

00:12:52,840 --> 00:12:58,480

And it was saying, your family can pay its respects now because you're mine.

195

And it was saying, you can run but you can't hide.

196

00:13:02,040 --> 00:13:05,760

The family refused to return to the house alone.

197

00:13:05,760 --> 00:13:09,920

Sightings agreed to send a team of ghost experts from the Office of Scientific Investigation

198

00:13:09,920 --> 00:13:10,920

and Research.

199

00:13:10,920 --> 00:13:16,000

When we go into a home to investigate, we look at first and foremost the environmental factors

200

00:13:16,000 --> 00:13:17,520

that are contributing to the situation.

201

00:13:17,520 --> 00:13:22,120

We look at the physiological elements and we look at the psychological elements of all

202

00:13:22,120 --> 00:13:24,120

those in the family.

203

00:13:24,120 --> 00:13:27,440

Specialists descended on the house armed with technology.

204

00:13:27,440 --> 00:13:32,200

Their aim was to electronically document any appearance by the supposed Beast.

205

00:13:32,200 --> 00:13:34,760

We call it a Beast because of the size of it.

206

00:13:34,760 --> 00:13:40,040

I remember I looked up and I could see it and it was just huge.

207

00:13:40,040 --> 00:13:41,480

I was not imagining it.

208

00:13:41,480 --> 00:13:43,320

I was not sleeping.

209

00:13:43,320 --> 00:13:45,920

It was very, very real to me.

210

00:13:45,920 --> 00:13:48,280

And then I felt the tongue.

211

00:13:48,280 --> 00:13:50,080

There was a very pointed tongue.

212

00:13:50,080 --> 00:13:53,080

The thing pushed me back on the bed.

213

And when it did, I felt this extreme weight on me.

It started screaming at me, very raspy, very deep voice.

215

And it was like, wow, wow, wow.

And of course at this point I'm screaming.

I know without a doubt that it was trying to have sex with me and it was trying to rape

There was just nothing I could do.

224

It is terrifying.

225

It's not something to sit around the kitchen table and say, oh, haha, the ghost was calling

226

00:14:39,480 --> 00:14:43,160

my name last night or the ghost wanted to have sex with me last night.

227

00:14:43,160 --> 00:14:44,160

Isn't that funny?

228

00:14:44,160 --> 00:14:46,240

It's not funny at all.

229

00:14:46,240 --> 00:14:51,000

Because of the women's terror, we had a security firm install 24-hour surveillance cameras

230

00:14:51,000 --> 00:14:53,040

throughout the house.

231

00:14:53,040 --> 00:14:56,400

Investigative devices were also put in place for the night long vigil.

232

00:14:56,400 --> 00:14:58,880

The team prepared to monitor the environment.

233

Radioactivity changes in light and electromagnetism and the temperature, sound frequencies and

234

00:15:04,440 --> 00:15:06,960

gravitational forces within the house.

235

00:15:06,960 --> 00:15:11,480

The neighborhood was also scoured for evidence of unusual levels of pollution or energy from

236

00:15:11,480 --> 00:15:13,000

power lines.

237

00:15:13,000 --> 00:15:16,480

Something to scientifically explain the phenomenon that plagues this family.

238

00:15:16,480 --> 00:15:20,200

I've seen a tall man with a very skinny long arm.

239

00:15:20,200 --> 00:15:24,640

It was just like a flash of light and it was so fast and it was at the end of the bed

240

00:15:24,640 --> 00:15:26,480

and I just started on me.

241

00:15:26,480 --> 00:15:29,440

Just like, pfft, just like did a belly flop right on me.

242

00:15:29,440 --> 00:15:33,800

And I was like stuck in this position and I couldn't move and I was like, mom, mom,

243

but I could not get my voice out.

244

He was like pins and needles but it was coming from the inside out and said it outside and

00:15:55,920 --> 00:15:56,920

Good night.

Good night.

254

00:15:57,920 --> 00:16:00,040

Everyone say their prayers.

255

00:16:00,040 --> 00:16:04,680

They tossed and turned, five in one bed, four other bedrooms empty.

256

00:16:04,680 --> 00:16:05,680

They were feet of freezing.

257

00:16:05,680 --> 00:16:06,680

Would you shut up?

258

00:16:06,680 --> 00:16:07,680

Kisses to the mid-night.

259

00:16:07,680 --> 00:16:09,680

I'm going to make a crunch.

260

00:16:09,680 --> 00:16:11,680

Let's rest.

261

00:16:11,680 --> 00:16:15,000

After midnight, one daughter came into the living room for a cigarette.

262

00:16:15,000 --> 00:16:19,400

It's about two o'clock in the morning and this usually seems to be the time when it'll

263

00:16:19,400 --> 00:16:24,400

start building up and you'll start hearing sounds in the house.

264

00:16:24,400 --> 00:16:29,280
