So we went ahead and looked at each other and we decided we'd better kind of see what's going on because it didn't seem normal.

Local resident Jerry Harris was one of a handful of civilians who reported strange phenomena that night. He recalls the encounter.

Well, they moved sort of sideways. This way, you know, they never go down and they come back up again. Most peculiar.

The next morning, British police investigated the area around the alleged sighting.

They found three circular impressions in the ground exactly 12 feet apart, forming a perfect equilateral triangle. The surrounding trees had been damaged.

It looked like something had landed there, came straight down through the trees and rested long enough to leave three, four inch indentations in the ground.

The next night, strange lights were reported again. Deputy Base Commander Colonel Charles Halt quickly assembled a special investigative team to search the woods.

angles, they'd go for a set distance.

Colonel Halt and his team not only witnessed the light phenomenon, but they were also able to document their sightings on film and audio tape.

Here he comes from the front. He's coming towards us now.

It's surreal.

330, 033 in the object. You're still in the sky. All over one of the signs looks like it's losing a little bit of altitude.

In the distance, you can see lights flying around and you can see like a stream of white light that came down to the ground.

Soon after that initial sighting, another strange UFO appeared at the airman, a single red hovering light.

Then the most extraordinary event of the night occurred.

Because of this inexplicable encounter, a special unit from European headquarters was dispatched to Bentwaters to take over the investigation.

We were told that whatever we saw there from then on, we were not to call in on the radio or report in.

People were aware of that something had happened or something could still be going on.

The team confiscated all physical evidence of the encounter, including Colonel Halt's tape recordings, films and memos.

All of that material was gathered up. It was considered technical intelligence. Therefore it went to Rammstein Air Force Base.

Now retired from Army intelligence, Clifford Stone was stationed at Hanau West Germany at the time of the Bentwaters investigation.

According to Stone, news about the UFO landing spread like wildfire.

I know that they considered that crack to be under intelligent control, and they did not consider that intelligence to be of this earth.

With so many credible witnesses, there's little doubt that something anomalous occurred that night.

Chuck DeCarro was a Defense Department correspondent for CNN who traveled to England to research the Bentwaters incident.

This was an important base. It had a nuclear weapons storage dump.

71

If these guys were hallucinating, as some debunkers have claimed, what were they doing guarding those self-same nuclear weapons the next day and the next week?

Others have speculated that the UFO was a top secret U.S. military aircraft used to test the responses of base security forces.

We exercised on a regular basis through every possible contingency at the ground troops, and there was no need for the Air Force to come up with something extra.

There is another possibility involving technology known as psychotronic or radio frequency weapons.

Any attempt to gather physical evidence at the site is now impossible. The alleged landing site has been destroyed.

All that there, yes, the whole lot, 10,000 acres was absolutely devastating.

British UFO researcher Brenda Butler has been investigating the Bentwaters sightings since 1981.

She claims that her efforts have been sabotaged by the U.S. and British governments.

The Ministry of Defense have been on to us and telling us to keep quiet and, you know, not to say anything about it.

My boss got nervous. After we started working again, he was worried about it trying to sneak around and trying to come do something to us.

Sneak attack is what he said.

Based on the high concentration of sightings here, our investigative team mounted an expedition into the area, headed by researcher Cliff Crook.

Cliff and his partner, Dean Smith, believed that only a small, unobtrusive team would have any chance of capturing a Big Foot on film.

It was just this kind of expedition led by Roger Patterson in 1967 that resulted in a startling piece of evidence.

This 16mm film was believed to be the only authenticated Big Foot footage to date. Patterson's partner, Bob Gimlin, was there.

When we came upon the creature, it was standing still by the crick. It immediately turned around and started to walk away.

00:13:21,000 --> 00:13:29,000

There is no way that this could ever be false-fied or any man could be in a suit because of the movement of the muscle underneath the hair.

122

The Patterson film is the second best evidence after some footprints.

123

Professor Grover Krantz heads the anthropology department at Washington State University. His scholarly research concludes that Big Foot is real.

124

This is one of the most interesting ones. It's a 14.5 inch track. It shows what we call dermal ridges, the little fingerprint type ridges.

125

These have been studied by police fingerprint experts and no one's found any flaw in any of them.

126

This one is the imprint of some knuckles with the right hand. You can see it's substantially larger than my hand and this is the thumb over here.

127

The individual apparently stumbled, hit the hand on the ground and left the imprint and the cast was made of those four digits curled around and the fifth digit, the thumb, coming out to the side.

128

Right here is the thumbnail, the edge of the thumbnail.

129

00:14:28,000 --> 00:14:37,000

Professor Krantz divides his research time between lab study and expeditions into the field. He is constantly searching for new evidence to support his theories.

130

His findings indicate that Big Foot is not a tunnel, a creature of the night. Sightings brought a specially equipped star-like filter into the research area.

131

00:14:46,000 --> 00:14:52,000

We hope that this night vision feature would increase our chances of finding an actual Big Foot.

132

00:14:52,000 --> 00:14:57,000

Unfortunately, bad weather forced us to end the investigation before any sightings occurred.

133

Soon after our team left the area, an anonymous videotape arrived with a Washington State postmark.

134

There are those who believe this is actual footage of a small, possibly female, Big Foot.

135

The creature appears in two sections of this VHS tape. The tape is played in its entirety.

136

00:15:18,000 --> 00:15:25,000

Here, the supposed Big Foot moves behind some trees and then unexpectedly turns toward the camera.

137

00:15:25,000 --> 00:15:31,000

Washington-based photo analyst Mike Stosser studied this videotape for sightings.

138

00:15:31,000 --> 00:15:35,000

The most compelling evidence in the tape is as simple as a head turn.

139

00:15:35,000 --> 00:15:42,000

In hoaxes, you see an animal that may be someone in a suit move with their head and their neck.

140

00:15:42,000 --> 00:15:50,000

And real Big Foot specimens would move as a gorilla with their entire torso and their head move similarly.

141

00:15:50,000 --> 00:15:57,000

The typical ape posture as the shoulder is carried very high and the mouse and the jaw is lower than the shoulder.

142

00:15:57,000 --> 00:16:01,000

So if an ape wants to turn its head, its jaw runs into its shoulder.

143

00:16:01,000 --> 00:16:09,000

The creature that Patterson watched turned its head and then the shoulder went with it in what you would expect with an ape.

144

00:16:09,000 --> 00:16:13,000

In the Patterson footage, you can see that the animal is walking straight forward,

145

00:16:13,000 --> 00:16:20,000

but then when he turns to see the cameraman, his entire body, his torso and all, moves up and to the right.

146

00:16:20,000 --> 00:16:27,000

Here in the most recent Washington footage, you've got the animal crouched into clearing here,

147

00:16:27,000 --> 00:16:33,000

and then as it starts to look towards the camera person, its entire torso comes up and to the left.

148

00:16:33,000 --> 00:16:38,000

Full body, not just the neck, but up and to the left, very similar to the Patterson footage.

149

Is this evidence of the legendary missing link?

150

00:16:43,000 --> 00:16:47,000

Experts are divided, but they all continue to gather evidence.

151

00:16:47,000 --> 00:16:53,000

Although there is no proof positive that Big Foot exists, to many the circumstantial evidence is overwhelming

152

00:16:53,000 --> 00:17:00,000

and researchers remain dedicated to finding that one piece of hard evidence that will finally lay the controversy to rest.

153

Joining us now is Richard Greenwell, Secretary for the International Society of Cryptozoology.

154

Richard has conducted numerous expeditions in search of Big Foot and the Loch Ness Monster.

155

Richard, thanks for joining us. You've had a chance to look now at the new Big Foot footage.

156

What do you make of it? Is it the real thing or a hoax?

157

I'd say probably a hoax.

158

00:17:21,000 --> 00:17:28,000

For one thing, the supposed creature looks very much like a costume to me.

Its gait and movement is wrong. The gait is very human-like and the movement is very slow.

160

00:17:35,000 --> 00:17:40,000

What else would you need to see to be sure that one exists?

161

Well, the only evidence that's going to convince the zoologists and the anthropologists is physical remains.

162

00:17:47,000 --> 00:17:53,000

Bones or a part of an animal or a complete animal dead or alive. That's the bottom line.

163

Is there any sort of photographic evidence or videotape evidence that you would find persuasive?

164

00:18:00,000 --> 00:18:12,000

If there was film footage that was in conjunction with extremely good eye-witness testimony from reliable people, then that would be a very strong case.

165

00:18:12,000 --> 00:18:20,000

Otherwise, when it's a videotape that comes in, you don't know who took it or is questionable, it has very little value.

166

00:18:20,000 --> 00:18:24,000

If you were a betting man, Richard, what would you say the odds are that there is a Bigfoot?

167

00:18:24,000 --> 00:18:33,000

Well, I may get into trouble for this, but I'd say, in my opinion, based on all the evidence I've looked at in the 3,000 reports,

168

I would say that the odds are just over 50% that there is a living Sasquatch or Bigfoot.

169

Richard Greenwell, thank you very much for being with us. And we will be back with more sightings in just a moment.

Coming up, a rash of UFO sightings in Wisconsin leads to a special investigation.

I did begin to believe that they did want me to film them for some purpose, for some reason.

Kevin Crump was driving his grandmother home when he grabbed his video camera.

178

At first, I thought it was a plane, but then when I slowed down and we looked, it shot out a blue light out of the back end.

179

00:19:43,000 --> 00:19:45,000

And we knew then it could have been a plane.

180

00:19:45,000 --> 00:19:50,000

A friend's phone call sent Beaver Dam resident Carol Putts into her yard with camera in tow.

181

00:19:50,000 --> 00:19:56,000

I believe that there is an intelligent life force out there somewhere, and I think it's visiting.

182

00:19:56,000 --> 00:20:04,000

Our dispatch center received about 12 calls from people stating that they had two seen these unexplainable lights in the sky.

183

There's no doubt in my mind that there was something there.

184

00:20:07,000 --> 00:20:11,000

Those first calls came in on January 31, 1993.

185

00:20:11,000 --> 00:20:19,000

Two sheriff's deputies tracked the strange lights for more than 20 minutes as they headed west, then sharply south into neighboring Jefferson County.

186

What we've had with these recent sightings in Wisconsin are incredible people seeing incredible things.

187

00:20:24,000 --> 00:20:30,000

And it's also an added plus when the individuals that are reporting are trained observers.

188

I believe the credibility of the people. I believe my deputies that they did see something.

189

00:20:35,000 --> 00:20:41,000

It's unexplained at this time. And as far as I'm concerned, I won't close it out until we have an answer to it.

190

And if that answer is visitors from another planet, at least one witness welcomes the possibility of an alien encounter.
