a warning that turned out to be more than just an idle threat.

Burial sites are among the most sacred of all places,

and there is almost a universal belief that the dead must be left to rest in peace.

Some Native American tribes follow these traditions to this day.

Members of the Delaware Indian nation believe this stretch of Highway 55,

near Deptford Township in New Jersey, was built over an ancient Indian burial ground,

prompting what has become known as the Curse of Highway 55.

To us, our ancestors are sacred, and anything that is connected with our ancestors,

the whole area to us is sacred.

We do not defile it in any way, and we don't want anyone else to defile it.

Well, they just laughed at me.

So I raised my hands to the heavens, and I prayed to the Great Spirit, and I prayed to my ancestors.

I mean, then the winds came up and blew vehicles off the road with their workers in them,

A sudden gust of wind blew yet another worker off a bridge, leaving him paralyzed.

Within three weeks, many more construction workers and their families seemed to fall victim to the

curse.

The sheer number of tragedies seemed to be more than coincidence.

Workers and their families are still frightened to speak out publicly.

Chief Wyandaga doesn't agree. He believes the site is sacred, and anyone who disturbs it is cursed.

I said if there was a village, then within a hundred yards in one direction or the other,

there would have to be a burial site, because after all they didn't have horses,

77

they didn't have any other means of transportation, so they had to carry the body and bury it.

The soils are fairly acidic, and organic remains do not last very long.

79

Two, three hundred years tops before they completely disintegrate into the soil.

So I said well even if there's no bones left, there still was a burial site.

Reincarnation is the process by which the soul, which is our spiritual essence,

at the end of a lifetime when the body dies, leaves that lifetime, leaves that body,

gets into a new body and starts a new lifetime.

Does reincarnation exist? Under hypnosis, Betty's clients try to reach back in time to a time before they were born.

They are searching their unconscious for evidence of past lives.

The technique is called regression therapy.

110

Once hypnotized, subjects seem to relive previous incarnations, recalling historical events,

people and foreign places they have no knowledge of.

Subjects say their previous lives come to them like snapshots from the past.

The philosophy behind reincarnation is that the soul has chosen to get into a physical body in order to learn something.

114

We are choosing to incarnate in each lifetime because we have certain lessons to learn in each lifetime.

Regression therapists work with people who want to go back in time and explore the possibility that they've lived before.

The first step involves total relaxation of mind and body.

Now take a stream of white light down through the top of your head.

Some people try past life therapy out of curiosity.

Others hope to learn if problems in this life are linked to traumatic events in a past life.

One of Betty's clients sought help for his clinical depression after traditional therapy failed.

Betty and I went back to a past life when I was happy flying, which happened to be a World War II fighter pilot.

So for instance something that gave me pain or gives me pain during this lifetime is cause for exploration of past lives.

I was a crew member on the Titanic down in the engine room.

141

00:12:25,000 --> 00:12:28,000

The ship is in trouble.

142

00:12:28,000 --> 00:12:32,000

I don't want to die. I don't want to go down with this ship.

143

00:12:32,000 --> 00:12:38,000

I can remember screaming all around me and then all of a sudden things turning upside down.

144

00:12:38,000 --> 00:12:46,000

The most disturbing thing is timber creaking and stretching and cracking ways that it's not supposed to.

145

Up until then I felt a sense of gravity and now it's all upside down and ropes.

I'm caught up in ropes.

147

I'm being dragged under.

I can feel a rope wrapped around here and I can see portholes of the ship.

I'm being pulled under by these ropes. I'm being pulled down with the ship.

150

This is a really frightening thing.

151

I watched myself tied up in the ropes go down, down, down and I can see the stern of the ship

152

and it disappears into this black fog water.

The Titanic sank in 1912, 40 years before Darrell was supposedly reborn in his present life.

154

During regression he was able to reveal the name of the sailor his soul had previously inhabited.

I just opened my mouth and this word came out.

His death scene is a very profound one because he had not expected to die.

We know that stuff's not real guys.

We know that there's not a marshmallow man walking down Central Park West.

177

00:15:41,000 --> 00:15:42,000

What do you really do?

178

00:15:42,000 --> 00:15:48,000

Until his death, Tony was everyone's favorite bartender at the Banta Inn near San Francisco.

179

00:15:48,000 --> 00:15:51,000

Locals believe his spirit haunts the restaurant still.

180

00:15:51,000 --> 00:15:54,000

But Tony's not a frightening malicious ghost.

181

00:15:54,000 --> 00:15:56,000

His trademark is mischief.

182

00:15:56,000 --> 00:15:59,000

There was a fella staring at me there.

183

00:15:59,000 --> 00:16:03,000

I went through the door of the kitchen and he was gone.

184

00:16:03,000 --> 00:16:09,000

I saw a figure in the mirror and I turned to look at the floor where that person should have been

standing and there was nothing there.

185

All of a sudden I felt this, like somebody took your finger up the back of my leg all the way up and I turned around and there was nobody there.

After that, the guy's beer right next to me tipped over, spun around three times.

All of a sudden the CDs started flipping by themselves.

He loved Patsy Klein and it would come on all the time.

Ghosts tend to react to situations as if they were people living and breathing people.

191

One of the reasons is they don't know they're dead.

192

They're in total denial.

193

00:16:36,000 --> 00:16:40,000

We have a lot of physical things happening that seem to relate to Tony's behavior when he was alive.

194

00:16:40,000 --> 00:16:50,000

One of the things that Tony was apparently fond of doing was playing with the money in the cash register and stacking the change so that it was a nice orderly sex in the changement.

195

00:16:50,000 --> 00:16:57,000

And here when you just toss money in a changement, obviously close the door up and open it back and forth, it's not going to stack automatically.

196

00:16:57,000 --> 00:17:01,000

And yet they've been opening the drawer for a few years and the change seems to be stacking by itself.

197

You can throw it in and turn around the next second and it's all stacked in there all nice and neat.

198

In the search for proof, investigators test Tony's favorite table with a magnetometer.

199

They're looking for abnormal levels of electromagnetism.

200

Oh my God, it's going off the scale.

201

00:17:16,000 --> 00:17:21,000

No, right as I was coming over here, it went off the scale, went up to about 100.

202

Unlike other hauntings Lloyd Auerbach has investigated, the people here aren't frightened.

203

One of the bartenders told me that she had pretty much gotten a couple of guys who were very drunk out of here and come back in and she didn't lock the door behind her, which she thought as an afterthought.

204

It turned out to have locked itself.

205

00:17:39,000 --> 00:17:44,000

And according to eyewitnesses, Tony is not the only ghost that haunts the band again.

206

From what I have been told, Margaret was an old regular in the 50s and 60s.

207

00:17:49,000 --> 00:17:56,000

She passed away. She died of a heart attack in the building and that she absolutely loved the band.

208

00:17:56,000 --> 00:18:00,000

She lived down here and that she didn't want to leave either.

209

00:18:00,000 --> 00:18:08,000

Margaret plays. She likes levitation. She likes throwing objects.

210

00:18:08,000 --> 00:18:13,000

Well, then came in order to hamburger and bartenders asked him something about how he wanted it done.

211

And that moment from across the room where there was no one sitting, an astray picked up off the table, flew across the room, passed the guy's head and dropped down in front of the bartender.

Even Lloyd has experienced what seems to be Margaret's temper.

The chandelier started moving by itself and there was no way for that to have happened if the other one wasn't always already moving, unless somebody rigged it.

And that's the first thing we did check.

In another haunting case at the Moss Beach Distillery in California, a deluge of eye witness reports warranted more sophisticated diagnostic tools.

Now what we're installing are three different types of motion detectors, an infrared detector, a microwave detector and an ultrasonic detector.

In addition to the detection devices, our back has assembled a team of psychics who will attempt to make contact with the spirits here.

You may have a lot of person witnesses, but no camera witnesses to objectify the actual phenomena that's going on.

Photographic evidence doesn't exist and there are no good photographs because we're dealing with a purely mental phenomenon where the ghost is somehow transmitting an image into your brain and bypassing the eyes altogether.

Apparently it was built as a residence to begin with.

221

00:19:22,000 --> 00:19:31,000

There was a garage downstairs and then it became a booming restaurant and a bordello, we think.

222

There was a piano player here and every evening a beautiful woman wearing blue would come to listen to him play and apparently they were having an affair.

223

00:19:40,000 --> 00:19:44,000

The only problem was that she was married and her husband was very jealous.

224
