Welcome to Sightings. I'm Tim White.

One of the most puzzling and controversial UFO sightings in U.S. history

To this day, many people who have studied this sighting believe there is a continuing government cover-up

As I discovered on my trip to Kecksburg, some believe the UFO was a meteor,

others that it was an alien spacecraft,

and some others that it was all an elaborate hoax.

18

Kecksburg used to be just like a lot of other small villages in western Pennsylvania.

19

But in 1965, Kecksburg lost its anonymity when it became one of the world's most famous UFO landing sites.

I happened to look up in the sky and I seen this red farball.

It sure wasn't a meteor, because I've seen them fall before.

Some claim the UFO wasn't the only thing to arrive that night.

I have a brother-in-law that he hasn't spoke to me for two years.

You've got neighbors and neighbors that has known each other all their life.

Now they don't want to talk cause one believes it and one don't believe it.

Just as the town is divided, so too are experts who have researched what really happened in Kecksburg.

60

Planetary expert Robert Young believes that some citizens may have perpetrated a hoax.

He claims the UFO was merely a meteor.

62

Known to have passed over Ontario in several northern states that evening.

63

Virtually all of the accounts can be explained by people having looked toward and seeing the Ontario meteor.

How about the accounts though of the military that turned out in large numbers,

kept people away from going down there, truck that went down into the area and came out.

I understand. I have written, signed eyewitness accounts from 61 local people

who say that that did not, that there was nothing crashed here, was recovered, there was no military occupant.

A lot of people probably think you're the government.

70

Well, sure, yeah, but I'm not.

I don't know how some people can say that nothing ever happened when there were so many people that saw things that night.

Something had to happen.

73

I know what I saw and I'm not going to deny it.

They can tell me I'm lying, but I know that I've seen the military in my house that night.

Freedom of Information Act states there was 212 military personnel here that night.

Sightings attempted to speak with the Kexburg residents who deny anything extraterrestrial ever happened here,

but they all refused our invitation to talk.

Even the landowner whose property was the alleged crash site remained silent.

Ironically, their refusal to talk has only deepened the controversy.

UFO researcher Stan Gorton heard about the Kexburg incident on the radio.

82

The night it allegedly happened in 1965. He's been investigating the sighting ever since.

83

So much of what we know about the case now we've learned since about 1987

84

with the fact that now we have at least four different eyewitnesses who apparently saw the object on the ground at Kexburg.

The fact that there are dozens of people independent of each other who don't even know each other yet

who have given us detailed information about what they experienced and saw that night

87

and they're giving us confirming information that has not been published yet.

The skeptics, and these include the people who own the land

89

and some very substantial citizens of Kexburg think that this whole thing is loony.

It could be that some of these people were in the wrong place at that time.

And if you see the geography of the area and where the majority of people were that night,

Do you have any hard evidence at all that what went down in the woods near Kexburg

96

As in so many of these cases, you have to go by the eyewitness accounts.

What do I think it is? At this point, and again, this is not conclusive,

If the object were proven to be a Soviet space probe, then many questions would be answered.

If a Soviet device landed in Kexburg, the government would have been required by international treaty

108

to recover and return immediately any space debris to the country of origin.

But retired Army Sergeant Clifford Stone doesn't believe the Soviet probe theory.

If this was of Soviet origin in 1965, the State Department would have released documentation to me under their Moondust files.

To date, none of that information has been forth.

Clifford Stone collects government documents about space debris recovery operations,

He began his investigations in 1965 when, as an Army Sergeant, he witnessed a top-secret delivery to Lockborn Air Force Base

about 200 miles from Kexburg.

I noticed that on the back of the vehicle, it had something that was covered by a tarp.

117

It was about 10 to 12 foot at the base, 12 foot tall.

It looked like a chocolate drop.

119

When my friend told me that every question I ever had about UFOs was under that canvas, I was mystified.

120

Since that time, Stone has repeatedly attempted to obtain information from the government regarding that object.

121

Each time, the government's response has been the same.

122

They have taken the stance by direction of the President of the United States.

123

We may neither confirm nor deny the existence or non-existence of any information that all involved the recovery of unknowns.

124

Kexburg remains a town divided.

125

The only thing on which believers and non-believers can agree is that all they want to know once and for all is what really happened on December 9th, 1965.

What would you like to see happen next?

127

It's time after 27 years that the public has to write to know the true facts, regardless of what the object was, and what really occurred.

Something came down from numerous eyewitness accounts to a lot of military activity into the small village.

Then an object was located, that it was recovered, it was transported away for study.

Mr. Oberg, first of all, do you believe that something crashed in Kexburg in 1965 and was it a UFO?

If it's anything, it might be something a lot more earth-like.

It might be a spacecraft from Russia and not from Mars.

136

It turns out we do know that a Russian probe fell back to earth that day, and it was a special kind of probe.

137

It was one of their probes to the planet Venus.

138

It failed, was trapped in Earth orbit, and eventually fell out of orbit.

What might have been on that Russian space probe that the U.S. would have been so interested in?

Oh, the most important thing about the probe would be the heat shield.

Also, their most advanced electronics would be in that probe.

Their most heat-resistant kinds of materials.

The very best of their entire military industrial complex technology.

It would have been a treasure trove in terms of the Russian space and missile technology.

Do you think we will ever know with certainty what really happened in Kexburg?

149

Well, I guess the dream is that someone will go forward with an official government report.

150

It might exist, it might not.

20, 30, 40 years ago, people's memories, as you know, tend to keep changing and growing as the stories get told and retold.

I think there's lots of stories in UFO folklore that will never really know what happened behind them.

That's the fascination.

Coming up next, a sinister entity has haunted this family for years.

Since 1978, Robert and Reba Malone and their four children have lived with frightening and confusing events

that make them believe the family is haunted by demonic entities.

They claim the hauntings began 14 years ago, the day their daughter Nikki was born.

163

Is there a connection?

164

The Malones believe there is, but others in their small Georgia community aren't convinced.

165

Carrollton, Georgia is home to at least one family who believes they're haunted

166

00:12:01,000 --> 00:12:05,000

and their strange plight has become the subject of radio talk shows in the area.

167

So let's go to the phone lines and welcome to afternoon talk.

168

Well, I'm not one of your people that goes to talk about a ghost.

169

00:12:11,000 --> 00:12:12,000

You're not?

170

00:12:12,000 --> 00:12:13,000

Nope.

171

00:12:13,000 --> 00:12:15,000

Mars, what do you think about that whole situation?

172

00:12:15,000 --> 00:12:16,000

A ghost?

173

00:12:16,000 --> 00:12:17,000

Yes.

174

00:12:17,000 --> 00:12:21,000

I don't more believe it than if I had a hole in my head.

175

On the rural farms just outside of town, in Carrollton's quiet neighborhoods

176

and on Main Street at the Pitty Pat Cafe, discussion about ghosts

177

and the unfortunate Malone family is unavoidable.

178

I've never met any yet, but I believe in it.

179

I don't believe in ghosts.

180

I haven't ever seen one and I don't believe nothing I don't see.

181

I think that the majority of the people believe in ghosts, but they won't admit it.

182

Whether or not the townspeople here believe in ghosts,

183

00:12:50,000 --> 00:12:53,000

they do admit that the Malone family is running scared.

184

00:12:53,000 --> 00:12:58,000

The children race home before dark, where they stand guard against what they believe are demons.

185

Since the Malones moved to this Carrollton home two years ago, things happened improved.

186

They fear any home they live in will become a battleground for something bizarre, something evil.

187

I definitely think it's the devil.

188

00:13:11,000 --> 00:13:15,000

I feel like that I can't protect my children from it.

189

00:13:15,000 --> 00:13:19,000

It's after this, kill one of us in the family, all of us.

190

I've wondered a lot of times if this evil spirit was working through our sick child, our sick doubter.

191

00:13:25,000 --> 00:13:35,000

Sometimes people turn to paranormal explanations because there is an explanation that they don't want to face.

192

They claim that terror started the day their youngest daughter was born, but that it's unrelated to her medical condition.

193

The family believes her brain damage, asthma and kidney transplant have nothing to do with the evil force that plagues them daily.

194

It's attacked my brother at one time, it's had him up against the wall of Chocohill.

195

He was swinging in midair, nothing was there, there was no arms, nothing.

196

Where is it at? You can't see it.

197

00:14:02,000 --> 00:14:10,000

I opened my eyes and it was a thing that was standing over me. It was real big and it was black. I couldn't move.

198

00:14:10,000 --> 00:14:16,000

I woke up and I saw something walking through the hall, but I couldn't have no head over there.

199

00:14:16,000 --> 00:14:22,000

All these people can't be seen and hear the same thing, so therefore it's not imagination, it can't be.

200

Part of the motive of the family is to hang together, and since their motive is to hang together, they would not necessarily say,

201

oh, don't believe that, that's not likely because that in a certain sense might threaten the togetherness, the sense of togetherness of the family.

202

Anybody that would experience it wouldn't know that it's real.

203

The Malone's daughter-in-law has recorded each paranormal encounter in her diary.

204

Her entries tell the story of the family in crisis, enjoying short lived periods of serenity, followed by days, weeks, even months of terror.

205

The family in Georgia is being plagued by inhuman evil spirits that are affecting their lives on every possible level.

206

00:15:08,000 --> 00:15:16,000

They have fled from house to house to try to escape this evil, but you cannot escape it.

207

00:15:16,000 --> 00:15:23,000

It must be dealt with, it must be documented, and it must be gotten rid of through spiritual means.

208

In 1990, the Malone's contacted Ed and Lorraine Warren, world renowned for their work with victims of what they feel is demon possession.

209

00:15:32,000 --> 00:15:36,000

First, they studied the family's claims and their psychiatric history.

210

00:15:36,000 --> 00:15:40,000

Only then did the Warrens agree to conduct a face-to-face investigation.

211

00:15:40,000 --> 00:15:44,000

A figure, a dark black figure, about four feet.

212

00:15:44,000 --> 00:15:48,000

I saw balls of light continuously, probably the size of a tennis ball.

213

00:15:48,000 --> 00:15:51,000

I had heard wrappings there, wrappings right underneath my feet.

214

00:15:51,000 --> 00:15:56,000

This audio cassette is the only record of the night the Warrens were working with the Malones,

215

00:15:56,000 --> 00:16:03,000

and claim a jar of pennies levitated and smashed into a researcher, and then a family member.

216

The Marlows and the Saints command you, reveal your identity.

217

00:16:08,000 --> 00:16:13,000

Give us a sign if you want the Malones out of this house.

218

00:16:17,000 --> 00:16:24,000

The pennies picked themselves up, jar and all, had to move out of the room, come through the door.

219

00:16:24,000 --> 00:16:32,000

It first clipped Joe hard on the shoulder, and then went and got the sun right in the face.

220

00:16:32,000 --> 00:16:39,000

And I was just terrified, and I ran out of the house. I was crying, my nose was bleeding.

221

00:16:39,000 --> 00:16:47,000

It was so heavy and so humid that night, and yet as soon as you started to provoke in that house,

222

00:16:47,000 --> 00:16:55,000

we were getting that psychic cold, it was coming like in waves, like as if there was a fan blowing from a freezer.

223

I could feel it on my ankles first, it was true psychic cold.

224

The women were shouting in and it was everybody's running around confused.

225

Eventually the phenomena ebbed, and things calmed down, but everybody slept in the living room that night.

No, I'm not crazy. No, I'm not on drugs. No, I don't drink, period.

227

It's not a fraud, it's not a hoax, it's not a psychologically disturbed family.

228

You want to call it devil's demons, I don't care, but there are things surrounding this family that are so terrifying,

229

that the average person looking at us right now could not in any way accept, unless they were there and living it.

230

After the Warrens first visit, family life seemed to return to normal, but those were rare moments of peace.

231
