Near the summit, the two women had a terrifying encounter.

We were merely poking around, actually trying to see where Gary Steier's house was from the top of the mountain.

When two men in a pickup truck pulled up, drove up the access road, and they both got out and one was older and one was younger.

They both had guns and they were incredibly angry.

Pam Zekosky never saw the two men again and believes they were not local.

She ran a search on their license plate number, but that has only deepened the mystery.

The plate number does not exist in any Pennsylvania motor vehicle record.

The identity of the two men is still unknown.

After the incident on Bald Mountain, the UFO activity has only increased and more witnesses have come forward.

It was just about dusk and as we were there by the power lines, all of a sudden these objects started coming up out of the treetops.

They were just everywhere, seemed wherever we turned. There was another one. I just remembered not hearing a sound.

But not everyone in the area believes the lights are UFOs.

Karen and Bob Siemens own the airport in Factoryville, about 10 miles south of Bald Mountain.

They believe people are simply sighting their newly installed beacon.

I think because we had put a new beacon up and people in the area were not used to seeing the light, I really think it's just too much of a coincidence.

Investigating the Siemens theory further, we took Gary Steyer's footage and overlaid footage of the airport beacon taken from the same angle.

Using the grid system, it appears impossible for the beacon and the lights to be one and the same.

We also took the videotape to ufologist Jeff Seino. After careful analysis, Seino has concluded that the lights are not conventional aircraft,

My impression of this tape is that it certainly wasn't faked.

But the day the boys, age four and six, told their mother, she told the police.

What happened in this house to those two children is an absolute nightmare.

The police found no proof of murder.

The family fled the house and called sightings for help.

If everybody's sleeping in the house is quiet, that's when it seems like it's the strongest.

I felt like I was dying.

Technician John Porre conducted physiological tests.

The family agreed to sleep that night with the lights out,

196

heads wired to measure sleep patterns and dreams.

Our camera was equipped with a night lens to photograph the house in darkness.

Christopher Shacone monitored the sensitive equipment.

This was one night the women wanted something to happen, but again, the house was silent.

could be rationally explained in one way or another according to the laws of nature and physics.

I still feel as strongly as we did in the first interview that those things happen in reality.
