My partner initially saw some strange lights. So we went ahead and looked at each other and we decided we'd better kind of see what's going on because it didn't seem normal.

At the very same moment, the control tower at London's Heathrow Airport reported the sudden appearance of several unidentified flying objects on radar.

I was going to bed and through the side windows here, I saw these lights.

Local resident Jerry Harris was one of a handful of civilians who reported strange phenomena that night. He recalls the encounter.

Well, they moved sideways this way and then they'd go down and then come back up again. Most peculiar.

The next morning, British police investigated the area around the alleged sighting.

They found three circular impressions in the ground exactly 12 feet apart, forming a perfect equilateral triangle.

The surrounding trees had been damaged.

The next night, strange lights were reported again. Deputy Base Commander Colonel Charles Halt quickly assembled a special investigative team to search the woods.

Colonel Halt and his team not only witnessed the light phenomenon, but they were also able to document their sightings on film and audio tape.

Here he comes from the fire. He's coming toward us now.

330, 0-330 and the objects are still in the sky.

Now retired from Army intelligence, Clifford Stone was stationed at Hanau West Germany at the time of the Bentwaters investigation.

According to Stone, news about the UFO landing spread like wildfire.

I know that they consider that craft to be under intelligent control and they did not consider that intelligence to be of this earth.

With so many credible witnesses, there's little about that something anomalous occurred that night. But what was it?

There was no doubt it was an identified flying object, which is what the UFO is.

Chuck DeCarro was a Defense Department correspondent for CNN who traveled to England to research the Bentwaters incident.

This was an important base. It had a nuclear weapon storage dump. If these guys were hallucinating, as some debunkers have claimed, what were they doing guarding those self-same nuclear weapons the next day and the next week?

Others have speculated that the UFO was a top secret U.S. military aircraft used to test the responses of base security forces.

I didn't really get a good look at him. He was running so fast. There was no human who could run that fast.

My boss got nervous. After we started working again, he was worried about it trying to sneak around and trying to come do something to us.

Sneak attack is what he said.

Based on the high concentration of sightings here, our investigative team mounted an expedition into the area, headed by researcher Cliff Crook.

Cliff and his partner, Dean Smith, believed that only a small, unobtrusive team would have any chance of capturing a Bigfoot on film.

It was just this kind of expedition led by Roger Patterson in 1967 that resulted in a startling piece of evidence.

This 16mm film is believed to be the only authenticated Bigfoot footage to date. Patterson's partner, Bob Gimlin, was there.

When we came upon the creature, it was standing still by the creek. It immediately turned around and started to walk away.

122

00:13:28,000 --> 00:13:37,000

There is no way that this could ever be false-fied or any man could be in a suit because of the movement of the muscle underneath the hair.

123

00:13:38,000 --> 00:13:43,000

The Patterson film is the second best evidence after some footprints.

124

00:13:43,000 --> 00:13:52,000

Professor Grover Krantz heads the anthropology department at Washington State University. His scholarly research concludes that Bigfoot is real.

125

00:13:54,000 --> 00:14:04,000

This is one of the most interesting ones. It's a 14.5 inch track. It shows what we call dermal ridges, the little fingerprint type ridges.

126

00:14:04,000 --> 00:14:09,000

These have been studied by police fingerprint experts and no one's found any flaw in any of them.

127

This one is the imprint of some knuckles with the right hand. You can see it's substantially larger than my hand and this is the thumb over here.

128

The individual apparently stumbled, hit the hand on the ground and left the imprint and the cast was made of those four digits curled around and the fifth digit, the thumb, coming out to the side.

129

Right here is the thumbnail, the edge of the thumbnail.

130

Professor Krantz divides his research time between lab study and expeditions into the field. He is constantly searching for new evidence to support his theories.

131

His findings indicate that Bigfoot is nocturnal, a creature of the night. Sightings brought a specially equipped star-like filter into the research area.

132

00:14:53,000 --> 00:14:59,000

We hope that this night vision feature would increase our chances of finding an actual Bigfoot.

133

00:14:59,000 --> 00:15:04,000

Unfortunately, bad weather forced us to end the investigation before any sightings occurred.

134

Soon after our team left the area, an anonymous videotape arrived with a Washington State postmark.

135

There are those who believe this is actual footage of a small, possibly female, Bigfoot.

136

00:15:18,000 --> 00:15:25,000

The creature appears in two sections of this VHS tape. The tape is played in its entirety.

137

00:15:26,000 --> 00:15:32,000

Here, the supposed Bigfoot moves behind some trees and then unexpectedly turns toward the camera.

138

00:15:32,000 --> 00:15:38,000

Washington-based photo analyst Mike Stosser studied this videotape for sightings.

139

00:15:38,000 --> 00:15:42,000

The most compelling evidence in the tape is as simple as a head turn.

140

00:15:42,000 --> 00:15:49,000

In hoaxes, you see an animal that maybe someone in a suit move with their head and their neck.

141

00:15:49,000 --> 00:15:57,000

And real Bigfoot specimens would move as a gorilla with their entire torso and their head move similarly.

142

00:15:57,000 --> 00:16:04,000

The typical ape posture as the shoulders carried very high and the mouth and the jaw is lower than the shoulder.

143

00:16:04,000 --> 00:16:08,000

So if an ape wants to turn its head, its jaw runs into its shoulder.

144

00:16:08,000 --> 00:16:16,000

The creature that Patterson watched turned its head and then the shoulder went with it, just as what you would expect with an ape.

145

00:16:16,000 --> 00:16:22,000

In the Patterson footage, you can see that the animal is walking straight forward, but then when he turns to see the cameraman,

146

00:16:22,000 --> 00:16:27,000

his entire body, his torso and all, moves up and to the right.

147

00:16:28,000 --> 00:16:34,000

Here in the most recent Washington footage, you've got the animal crouched into clearing here,

148

00:16:34,000 --> 00:16:40,000

and then as it starts to look towards the camera person, its entire torso comes up and to the left.

149

00:16:40,000 --> 00:16:45,000

Full body, not just the neck, but up and to the left, very similar to the Patterson footage.

150

Is this evidence of the legendary missing link?

151

00:16:50,000 --> 00:16:54,000

Experts are divided, but they all continue to gather evidence.

152

00:16:54,000 --> 00:17:00,000

Although there is no proof positive that Bigfoot exists, to many the circumstantial evidence is

overwhelming,

153

00:17:00,000 --> 00:17:07,000

and researchers remain dedicated to finding that one piece of hard evidence that will finally lay the controversy to rest.

154

Joining us now is Richard Greenwell, Secretary for the International Society of Cryptozoology.

155

Richard has conducted numerous expeditions in search of Bigfoot and the Loch Ness Monster.

156

Richard, thanks for joining us. You've had a chance to look now at the new Bigfoot footage.

157

What do you make of it? Is it the real thing or a hoax?

158

I'd say probably a hoax.

159

00:17:28,000 --> 00:17:35,000

For one thing, the supposed creature looks very much like a costume to me.

160

Its gait and movement is wrong. The gait is very human-like and the movement is very slow.

161

What else would you need to see to be sure that one exists?

162

Well, the only evidence that's going to convince the zoologists and the anthropologists is physical remains.

163

Bones or a part of an animal or a complete animal dead or alive. That's the bottom line.

164

Is there any sort of photographic evidence or videotape evidence that you would find persuasive?

165

00:18:07,000 --> 00:18:19,000

If there was film footage that was in conjunction with extremely good eyewitness testimony from reliable people, then that would be a very strong case.

166

Otherwise, when it's a videotape that comes in, you don't know who took it or is questionable, it has very little value.

167

If you were betting, Richard, what would you say the odds are that there is a Bigfoot?

168

Well, I may get into trouble for this, but I'd say, in my opinion, based on all the evidence I've looked at in the 3,000 reports,

169

I would say that the odds are just over 50% that there is a living Sasquatch or Bigfoot.

Richard Greenwell, thank you very much for being with us. And we will be back with more sightings in just a moment.

Coming up, a rash of UFO sightings in Wisconsin leads to a special investigation.

We receive home videos from all over North America of what viewers believe are UFOs.

A bright light outside of Julie Graceffa's bedroom window compelled her to grab her camcorder and shoot into the Milwaukee night.

I did begin to believe that they did want me to film them for some purpose, for some reason.

178

00:19:38,000 --> 00:19:43,000

Kevin Crump was driving his grandmother home when he grabbed his video camera.

179

00:19:43,000 --> 00:19:50,000

At first, I thought it was a plane, but then when I slowed down and we looked, it shot out a blue light out of the back end.

180

00:19:50,000 --> 00:19:52,000

And we knew then it couldn't have been a plane.

181

00:19:52,000 --> 00:19:57,000

A friend's phone call sent beaver dam resident Carol Putz into her yard with camera in tow.

182

00:19:57,000 --> 00:20:03,000

I believe that there is an intelligent life force out there somewhere and I think it's visiting.

183

00:20:03,000 --> 00:20:11,000

Our dispatch center received about 12 calls from people stating that they had two seen these unexplainable lights in the sky.

184

00:20:11,000 --> 00:20:14,000

There's no doubt in my mind that there was something there.

185

00:20:14,000 --> 00:20:18,000

Those first calls came in on January 31, 1993.

186

00:20:18,000 --> 00:20:26,000

Two sheriff's deputies tracked the strange lights for more than 20 minutes as they headed west, then sharply south into neighboring Jefferson County.

187

What we've had with these recent sightings in Wisconsin are credible people seeing incredible things.

188

And it's also an added plus when the individuals that are reporting are trained observers.

189

I believe the credibility of the people, I believe my deputies that they did see something.

190

It's unexplained at this time and as far as I'm concerned, I won't close it out until we have an answer to it.

191

And if that answer is visitors from another planet, at least one witness welcomes the possibility of an alien encounter.

Who says we're the only life forms around? Something or somebody living has got to be somewhere else.

You know, we're not that special.
