We came to the castle today to try to capture ghosts.

A paranormal agenda is quite common for the guests at the Manrasa.

People come from all over the country because they believe the third floor castle turret is an energy vortex that allows spirits to travel between dimensions.

People commonly come from all around to see the ghosts. There are people in Seattle that come here regularly to see ghosts, especially on equinoxes.

The third floor of the Manrasa Castle is supposedly haunted by several different ghosts.

Objects came off the walls and Kathy felt a mysterious presence watching her.

I was in the bathroom and he was looking in at me as I was taking a shower.

I turned a look and he disappeared.

147

Things got much worse for the family when three-year-old Mikey started describing apparitions in his bedroom at night, an apparition that took the form of a clown.

He's just totally, deathly afraid to be in his room by himself.

He will sit there and cry and scream that he's scared and he would say, the clown is in my room.

The Thomasons believe it may be the spirit of a boy who followed them home after a weekend trip to what had been a country club.

We had come here to see what was going on because we had heard the rumors of devil worship.

It's since burned down, it was arson, but we think this is where we picked up the spirit of the little boy.

Many parapsychologists theorize that spirits can attach themselves to living people for security.

But why then would the little boy be tormenting the family?

I brought in a magnetometer that measures magnetic fields and we have found that psychic experiences seem to occur in regions where there are strong magnetic fields.

Unusually high levels of electromagnetism were found in the hallway between the two boys' rooms.

So we have a high magnetic field in this area.

Then he interviewed each family member. He was particularly sensitive to the fears expressed by Mikey.

Show me where you saw the clown up. Just point to it.

The results of Dr. Rowe's investigation failed to prove conclusively that a ghost exists in the home.

170

He did however have a recommendation based on his findings.

171

They need to get rid of the strong magnetic fields in the bedrooms of the two boys.

172

The main electrical wires coming into the home are located directly adjacent to the boys' rooms.

173

There may be a connection between this electric source and the experiences of Jimmy and Mikey.

Psychic Irene Hughes was also part of our sightings investigation.

175

She carefully examined each room and tried to telepathically communicate with any spirits in the home.

Irene then worked with Mikey, guiding him through a series of specially designed exercises.

Her goal was to help him cope with his fears.

In Ventura, California, there have been unsettling reports of spirits haunting what was a turn-of-the-century hospital.

The haunting began at a city landmark.

199

High above Ventura, California, the old Bard Hospital has been the scene of numerous ghost sightings.

200

And now, reports of haunting activity are coming from almost every building on this block.

201

Local residents are scared, and they've called in Christopher Chacon, Peter Ackroyd and John Berry

202

from the Office of Scientific Investigation and Research.

203

We were contacted by various people in this community because there have been a variety of strange events occurring,

204

00:17:34,000 --> 00:17:36,000

including apparitions or ghosts if you want to call them.

205

00:17:36,000 --> 00:17:39,000

We haven't been able to discern that specifically.

206

00:17:39,000 --> 00:17:43,000

But some pretty spooky kind of stuff has been going on up here, so we thought we'd check it out.

207

It opened up this far for fully a beat, and then it closed again.

208

I was sleeping, it was about 2.30 in the morning, and a voice said,

209

hey, woke me up and I felt a tap on the shoulder.

210

He had a very cold, strange look in his face, almost very empty.

211

For the last several years, residents claim that an entity, or entities,

212

have made the presence felt to those who live and work around the hospital, now converted to offices.

213

00:18:16,000 --> 00:18:20,000

Tina, a former office worker, claims to have encountered several spirits.

214

00:18:20,000 --> 00:18:24,000

Her identity is hidden because Tina fears were prizes from the spirits.

215

00:18:24,000 --> 00:18:29,000

I felt a cold hand touch my shoulder, and I looked in the direction,

216

00:18:29,000 --> 00:18:37,000

and standing there was this old man with white, gray hair, and I just remember his face was very defined.

217

00:18:37,000 --> 00:18:43,000

This startled me so bad, I just stormed down the stairs and headed out the door, and the door slammed shut.

218

And I looked, and the guy was there again.

219

Some believe this old man, who has been spotted on several different occasions,

220

00:18:54,000 --> 00:18:58,000

is actually the spirit of Cephas Bard, founder of the original hospital.

221

It's assumed, it's Dr. Bard. I'm told that there's another presence, which is a young girl.

222

00:19:04,000 --> 00:19:09,000

She was apparently run over by a milk wagon or something, and she died in this hospital as well.

223

But there are other theories about the paranormal activity plaguing this neighborhood.

224

I have found that ghosts seem to be active in areas where you have different cultures in conflict.

225

And here we have the Indian people, the Spaniards, Mexicans, Chinese, Yankees, all sorts of different people.

226

And when you have these groups, sometimes a bloody confrontation that leaves things behind.

227

The structures in this Ventura neighborhood were built on the site of an ancient Chumash Indian burial ground.

228

Could this be the source of the haunting?

229

00:19:44,000 --> 00:19:51,000
