a sightings-investigating team has obtained the actual radio transmission

between a flight control center in Albuquerque and an America-West Boeing 757.

Based on these transmissions, we've been able to recreate a startling encounter

15

between a commercial aircraft loaded with passengers and an unknown craft six miles above the Earth.

The voices are real. The words are not scripted.

The object is not on radar. The tone of the radio communication begins to change.

Stay permanent.

Albuquerque controllers contact the military for an Earthbound explanation.

There is a beach called Shikmona just before the city of Haifa.

He sees a red object fly into the air, hover, dip.

93

Underneath there was a red glowing spot about one and a half meters in diameter.

There were immense flashlights and there was a very loud noise of whirlpool as if a helicopter was going to crash.

95

He stops his car, gets out of the car, sees the object return and there is a huge flash.

96

It suddenly disappeared. Only a big red spot remained and in a second it leaped into the sky and vanished.

We were chatting and suddenly my sister looked up towards the window and saw a glittering light in

the air.

I got up quickly and we both rushed over to the window. I told her, do you know what that is? That is a UFO.

The light was golden, like nothing I've ever seen in my life. A real light beam radiating out from it. It was shocking. Truly shocking.

There was a UFO that stayed there 17 minutes over the sea and then disappeared very quickly until it became small as a star.

It looked a little bit like a boomerang, but it was a shape that I never saw before. It had a unique power in color,

a special glow which was very different from anything I saw before. I didn't know how to react.

He radios in to headquarters, calls the Air Force, says, this is what I got.

They asked for the exact location of the object. I gave them the location and they couldn't find the object on the radar.

Because of Bait-Shawn's close proximity to the Jordanian border, the Israeli Defense Forces sent 300 troops into the area to track the unidentified craft.

135

00:12:30,000 --> 00:12:38,000

It was dragging a convoy of armed men for three hours on a trail up to the Jordanian border, which is a very sensitive place,

136

00:12:38,000 --> 00:12:46,000

but it seems to know where the Jordanian border is and heads back. At a quarter to six in the morning, in broad daylight, it disappeared in a flash.

137

Chameish has developed a controversial theory that these three UFO sightings are part of a pattern dating back to biblical times.

138

People who have been studying UFOs seriously around the world have reached the consensus that the Bible is a convincing UFO story.

I came to the same conclusion that the Old Testament, from the pillar, the cloud that led the Hebrews out of Egypt that glowed at night and stopped the Egyptians all the way through the prophets, were in fact UFO related.

140

Chameish also believes that stories of alien abductions in Kadima, as reported previously on sightings, are also part of the centuries old pattern.

141

Shikmona, they were announcing, in black and white, we are here. At Beit Shahn, they're saying, all right, now we've got five, six hundred of you seeing us, and you can shoot at us if you want.

142

Kadima was stage three, we want to meet you.

143

00:13:52,000 --> 00:13:59,000

And stage four, according to Chameish, is foretold in a prophetic passage from the Bible.

144

From Kedim, they shall go up to Jerusalem. In other words, Kadima is the next hop towards the revelation of the UFOs in Jerusalem.

145

The investigation in Israel is ongoing. A sightings team is now following up on late reports of activity in the town of Yatzitz on the Mediterranean Sea.
