what made you want to become a Navajo Ranger\h\h

well uh 1980 I actually was looking for a job\h
and uh they said at the chapter house they said\h\h

there's an opening for a Navajo Ranger had no\h
idea what it was um I ended up applying the uh\h\h

gave me a ride to Window Rock which is about 130\h
miles away from where I live and I walked in and\h\h

the director there asked me one question uh how\h
would you feel if somebody threatened your life\h\h

and I told him uh well I'll cut their\h
ears off at 200 yards of the 300 Savage\h\h

and they said you're hired next thing I know I was\h
in the police academy for six months and so I kind\h\h

of blundered into it and found out I was pretty\h

good at it and uh yeah here I am today I retired\h\h

about you what what made you want to become an\h
Navajo Ranger I think growing up uh uh in a rural\h\h

setting in in Oklahoma uh me and a cousin of mine\h
that was a couple years older than me uh at the\h\h

age of like 10 years old nine years old riding\h
dirt bikes motocross bikes and playing cops and\h\h

robbers and watching really too much uh Starsky\h
and Hutch and SWAT and uh so so I was at the\h\h

37

University of Arizona when I was contacted by the\h
uh director of Parks and Recreation an individual\h\h

38

named Clarence Gorman and uh he asked uh if I\h
would come back and uh attend the police academy\h\h

and uh that's what I chose to do so that's I I\h
became a Nava Ranger interesting okay and then you\h\h

know eventually you guys would both meet and start\h
working together um however I'd love if you could\h\h

just paint a picture for us now I know the Navajo\h

territory that you covered as Rangers was was vast\h\h

um but what exactly is a Navajo Ranger for those\h
who may not be aware of what the duties actually\h\h

entail um um you know the the the areas that\h
you covered um either one of you if you want\h\h

to cover that what exactly is a Navajo Ranger and\h
what areas did you cover okay so a Navajo Ranger\h\h

is a very specialized law enforcement officer\h
what he does is he handles uh both renewable\h\h

46

and non-renewable resource law enforcement so we\h
were trained and operated in the areas of Fish\h\h

47

and Wildlife Forestry Parks and Recreation areas\h
we would enforce the laws in those areas minerals\h\h

mines Water Resources we were also tasked with\h
handling search and rescue and um and Technical\h\h

rescue situations and then we also did police work\h
on the side when there were no police officers\h\h

present or able to respond to something\h
or if there was a life or death emergency

weapons and tactics call out SWAT call out

so he and I did that I worked on a drug
and gang task force under that section

of some really high profile and sensitive uh

like that so it was it wasn't just what people

it was kind of a broad spectrum of enforcement so

you know that the Paranormal was maybe one percent

for audiences like ours of course those are the

but um let's let's dive into that I guess that\h\h

one percent um what was it like for both of you\h
personally when you first got assigned to these\h\h

just another day at the office when when you\h\h

were told that you were now going to be going\h
out and investigating ghost scripteds UFOs Skin\h\h

Walkers things like this um Jonathan maybe\h
we'll start with you what was it like that\h\h

first day when you learned you'd be working\h
on these quote unquote special investigations\h\h

well the uh the director had a uh the chief\h
Ranger had a meeting with the entire department\h\h

and basically there had been an investigation and\h
if you know these guys that went out there uh two\h\h

rookies uh they were regular Jokers they would\h
laugh and joke all day long and just have these\h\h

little private um uh jokes about you know around\h
them and they went up to a lady that lost one of\h\h

her sheep to a Bigfoot and of course they were\h

laughing joking you know horsing around and she\h\h

took an offense to that and thought they were\h
laughing at her and chewed out her our chief\h\h

Ranger so he called everyone in basically told\h
us that these cases were would be investigated\h\h

request it we didn't raise our hands or anything\h\h

and suddenly we were told that we would be getting\h
the major cases involving uh paranormal stuff and\h\h

point that we we were assigned to attend this uh\h\h

it was just an everyday um a regular day and uh\h\h

but we did have a department-wide staff meeting\h
we were called into that meeting and um so heading\h\h

up that special projects unit the one of the\h
main reasons we were a part of that was that\h\h

I think the chief Ranger at that time we worked\h
really close with him we were probably uh the the\h\h

closest Personnel working directly with the chief\h
and we had developed a this relationship where he\h\h

knew he could give me and John uh assignments and\h
regardless of how how technical they were or how\h\h

87

um how difficult they might be that he could rely\h
on me and John to handle it regardless and that\h\h

John and I think I think with him had developed\h
a reputation of dependability and reliability and\h\h

professionalism so um so when we got assigned uh\h
it wasn't like John and I were over there raising\h\h

our hands saying oh we want to we want to run this\h
whatever that that wasn't the case it was simply\h\h

that Chief had this assignment and he looked at us\h

too and said you two are the ones that are going

to manage uh these assignments or these cases
investigations so hahaha at first you know it

93

was kind of like all of the other assignments we
had received it's it's yes sir and and uh you did

94

what you were told you know and uh but I don't
think that we you know yes John and I had had

95

uh uh all our own personal experiences with what
would be termed as Supernatural or paranormal

even prior to those assignments and even actually
there was there was cases we did that prior to

97

that that would have fallen under what would
be termed as um paranormal or Supernatural but

98

um so I think that kind of it facilitated
us to get right into that and get busy

99

investigating these things and stuff
so right for me it's just one of those

100

those another assignment you know that we're
given and so we were gonna do it regardless of

the nature of what it was right that was

actually going to be one of my questions for\h\h

you guys was were there ever instances where uh\h
you know you went into a case to investigate and\h\h

um that you then it turned into a paranormal\h
case like it it wasn't you weren't sent out\h\h

104

to investigate someone who had a Bigfoot sighting\h
but um you know boom all of a sudden you're in the\h\h

105

middle of you know a quote-unquote conventional\h
investigation of something else and I don't know\h\h

106

a UFO zipped by or or a you know a paranormal\h
event occurred did that ever happen to you guys\h\h

oh and things like that would happen all the time\h
um there there are many many cases uh where their\h\h

paranormal would kind of peek at you and you'd\h
understand that hey there's there's something\h\h

more going on here and um for the most part you\h
just kind of ignored it or let it be on the side\h\h

did your report uh try to maintain as many factual\h
uh stuff as you could within the report and it was\h\h

just kind of uh you know it was understood it was\h

there hmm interesting so I guess let's start from\h\h

the beginning when these cases were assigned\h
to you guys do you remember the very first\h\h

quote unquote paranormal case that you\h
were you were assigned to any memories\h\h

of what that was and and how it kind of LED\h
you down the path we got a uh case initially\h\h

115

um what had happened was that this is one of\h
the ones that showed up on the Netflix series\h\h

we had at least 30 people have sightings\h
of Bigfoot uh right around that Bloomfield\h\h

117

between Bloomfield and Shiprock along the San Juan\h
River and um they they were frightened and the\h\h

118

00:15:34,800 --> 00:15:43,020

Community had gone to the local police department\h
and says hey you know we got all these sightings\h\h

119

of this Bigfoot and the lieutenant came out and in\h
front of everybody just laughed at them and went\h\h

120

I wonder how much these people have had to drink\h
and so they basically turned their backs on the\h\h

121

police and said you know we don't we want nothing\h

to do with you guys and they contacted the Rangers\h\h

122

uh we sent a six-man crew up there and spent three\h
days and two nights uh thoroughly investigating\h\h

the case getting statements from people along\h
the river and uh collecting uh hair evidence\h\h

foot track evidence and things like that and\h
did determine that there was something going on

interesting Stan do you have anything to add\h
to that that first Bigfoot investigation you\h\h

126

guys went on and uh you know what did was this\h
something that you you were familiar with before\h\h

127

getting involved and um yeah how did you come out\h
on the other side thinking about Bigfoot after\h\h

128

that that assignment that you're talking about\h
that he's referring to up along the San Juan River\h\h

it really was the first where we're involving\h
a number of Rangers uh assigned uh to an\h\h

130

actual investigation that there was obviously\h
within that realm of paranormal investigation\h\h

um I don't think I actually witnessed uh\h

what people refer to as a Bigfoot until\h\h

132

later on in some other investigations where I\h
actually witnessed um what it is people refer\h\h

to as a Bigfoot twice I'm having an experience\h
where I've seen uh this either entity or this\h\h

you know I'd whether it's a creature or\h
uh but anyway so prior to that you know\h\h

um to that particular assignment I really didn't\h
have a whole lot of experience in that but but\h\h

um it did involve an entire team and\h
it involved the planning uh for that\h\h

assignment and the equipment that would be\h
needed and uh um really uh opened my eyes to\h\h

to [Music] how really how involved the\h
entire community in that area was actually\h\h

139

having witnessed this thing that people referred\h
to as Bigfoot so this is primarily a UFO podcast\h\h

um so I know our listeners are going to\h
want to hear from you guys about that\h\h

um so John let's start with you what is your most\h

memorable I guess investigation that involved the\h\h

142

mysteries in our skies well this again would\h
be one of our one of our cases we refer to it\h\h

143

as the old man case in this incidence uh an\h
elderly man was home by himself uh this is\h\h

144

00:19:17,820 --> 00:19:24,780

the short version uh there's other versions of\h
it that go into much more detail but uh we had\h\h

145

00:19:25,320 --> 00:19:32,880

this situation where this old man his his wife\h
and daughter had gone to to Phoenix and so he\h\h

146

00:19:32,880 --> 00:19:40,080

was home by himself it's uh midnight or one\h
in the morning and he sees a light and it\h\h

147

00:19:40,080 --> 00:19:46,260

looks like to him it looked like a car coming\h
up the road uh it turned out that it was this\h\h

148

00:19:46,260 --> 00:19:51,480

craft that was flying uh circled his house\h
and then landed up on the ridge behind him\h\h

149

00:19:52,980 --> 00:19:59,880

um he sees something come out of the crap out of\h
the bottom and go down to a house maybe a half\h\h

150

00:19:59,880 --> 00:20:09,360

mile away go back up to the craft and then come\h
back toward his house his dog starts barking uh\h\h

151

00:20:09,360 --> 00:20:17,700

it's it's a little blue heeler pup and uh you\h

know it goes running out they're barking and he\h\h

152

00:20:17,700 --> 00:20:23,640

hears it you know Yelp and it comes running back\h
to the house and curls up by the front doorstep\h\h

153

00:20:23,640 --> 00:20:31,440

and just lays there uh doesn't move so now he's\h
getting nervous and he goes inside he's looking\h\h

154

00:20:31,440 --> 00:20:39,300

out the window on the Seas what could be described\h
as a gray alien uh four of them that have these\h\h

155

00:20:39,300 --> 00:20:46,320

little flashlights in their hands he calls it\h
flashlight but it has a collimated beam about\h\h

156

00:20:46,320 --> 00:20:56,700

an inch in diameter and different color beams\h
of light red blue uh yellow and uh and green\h\h

157

and they're shining it around looking like\h
they're looking for something uh out around\h\h

158

his house he has all these solar lights and they\h
they seem to be very fascinated by these lights\h\h

159

and as they approached them and gather around\h
the light the light slowly dims and goes out\h\h

160

um they back up they stand up again and\h
back up and the light comes back on again\h\h

161

and they would lean in again and the light\h

would go out this happened several times\h\h

162

um finally he decides he's in Navajo there's\h
no word for alien so he's saying what are these\h\h

163

little children doing around my house he says they\h
they were wearing these uh white skin tight suits\h\h

164

either white or light gray and so he goes out\h
to confront them he says they had big heads and\h\h

165

00:21:56,100 --> 00:22:03,540

they had black eyes and as he turns the corner\h
around the back side of the house he tripped on\h\h

166

00:22:03,540 --> 00:22:11,580

the step and fell broke his flashlight and as he\h
looked up these things were hightailing it away

167

in later conversations he describes\h
them as as being startled and having\h\h

168

00:22:20,460 --> 00:22:30,240

their hands up and waving them and um\h
and then you know getting away uh so\h\h

169

00:22:31,020 --> 00:22:38,580

they get back to the ship they take off\h
and uh he he doesn't know what the result\h\h

170

00:22:38,580 --> 00:22:45,540

of that was later on we found out a couple\h
of weeks later that that little dog had died\h\h

171

we didn't know about it at the time otherwise\h

we could have had it in a crop seed and we did\h\h

172

00:22:51,780 --> 00:22:58,920

a full investigation there with a federal court\h
interpreter doing simultaneous translation for us\h\h

173

that's a really interesting case a close\h
encounter of the Third Kind I would say\h\h

174

um and very dramatic if you ask me and\h
what I appreciate is you know you guys\h\h

175

aren't just out there taking witness testimony\h
you're actually trying to find evidence find\h\h

176

proof of these things which was you know\h
shown in the Unsolved Mysteries episode\h\h

177

um of testing a car where a UFO hovered above it\h
and things like that so um I I found that really\h\h

178

interesting Stan how about in you in terms of uh\h
UFO investigations anything really memorable stick\h\h

179

00:23:38,520 --> 00:23:46,920

out to you about um UFO activity over the Navajo\h
territory one of the UFO experiences that John\h\h

180

00:23:46,920 --> 00:23:54,060

and I had it hadn't started out as an actual\h
paranormal related case it was a drowning uh\h\h

181

00:23:54,060 --> 00:24:01,140

an individual had drowned uh somewhere in the San\h

Juan River and John and I had placed a boat in in\h\h

182

00:24:01,140 --> 00:24:11,220

the water at Lake Powell and began traversing to\h
the to the east along in the San Juan River and\h\h

183

00:24:11,220 --> 00:24:20,160

um so we got so far and it was getting late in\h
the day uh we came to a debris field where we\h\h

184

00:24:20,160 --> 00:24:27,960

couldn't go any further uh for fear of damaging\h
the prop on the boat and so we just pulled off we\h\h

185

00:24:27,960 --> 00:24:36,000

decided we would we would camp for the the rest\h
of the day and evening and uh so we set up camp\h\h

186

00:24:36,600 --> 00:24:48,960

and that night uh uh really clear sky I we we\h
were laying on our cots and I noticed an object\h\h

187

00:24:49,680 --> 00:24:54,060

uh that was coming from the West\h
headed in the East Direction\h\h

188
