No one believes his friends account of the incident and they are suspected of murdering

When he finally turns up five days later, he claims to have been taken on board an alien

152

spacecraft and placed on a peculiar chair with many signal lights.

When he sits on it, the walls disappear and he finds himself in the void of the building.
