Photo analysis conducted by MUFON concluded that this object was 27 feet wide and 12 to 13 feet long,

with no visible means of propulsion.

114

Other UFOs sighted in American airspace have behaved similarly,

115

namely the Tic Tac craft that was filmed by US Navy pilots in 2004.

The Tic Tac was reported to hover in space almost unnaturally before taking off in whatever direction it pleased,

at near supersonic speeds.

What part of the sky did you take this with?

I mean, where was your trail cam pointed in relation to the sky here?

Over the course of his career, his job has been to separate fact from fiction in sightings all over the state.

129

Ectrish's sightings ring authentic. John will know.

130

00:09:17,000 --> 00:09:22,000

So John, could you tell me when did you first interact with Trish?

131

I was the chief investigator for MUFON, and so all reports come to me for Florida.

132

Trish submitted an exciting report, and I started reading the report,

133

and the first line was, you're not going to believe this, but I saw an invisible spaceship.

134

For the majority of her life, she'd been a security specialist working for government contractors.

145

When I found out what her background was, it's like, okay, this lady's not sitting here lying.

Exactly. I drove a little over an hour to where she lived at the time.

We talked for quite a while. We walked down in the woods when she told me what she saw. I took pictures.

John's takeaway was the same as Ben's.

151

Trish was a highly credible witness with a lot to lose, who encountered something extremely threatening.

152

Well, with all that you've done and people, witnesses that you've talked to, where does this case rank as far as credibility?

153

It's probably one of the top three. We looked at a photo that she had taken.

154

00:11:14,000 --> 00:11:16,000

Was this from the trail cam?

155

00:11:16,000 --> 00:11:18,000

Yes, this was from the trail cam.

156

00:11:18,000 --> 00:11:26,000

As it turned out, there had been a sighting about six months earlier by somebody else, 11 miles away.

157

00:11:26,000 --> 00:11:28,000

And you think it's the same object?

158

00:11:28,000 --> 00:11:31,000

I would say there's definitely a possibility.

159

00:11:31,000 --> 00:11:34,000

So was any analysis done on the photo?

160

00:11:34,000 --> 00:11:37,000

Yes. It was sent to the photo analyst.

161

00:11:37,000 --> 00:11:42,000

He was able to determine it was maybe 27 feet long, 12 or 13 feet high.

162

00:11:42,000 --> 00:11:46,000

He couldn't tell how wide it was because of the angle it was passing.

163

00:11:46,000 --> 00:11:51,000

There was no visible means of propulsion, no wings on it, no rotor blade.

164

00:11:51,000 --> 00:11:56,000

Moving very slowly, it's like, OK, why is it staying up there? Why doesn't it fall?

165

00:11:58,000 --> 00:12:04,000

John, do you have any opinions on why you think the creature was here and visiting?

166

00:12:04,000 --> 00:12:10,000

It definitely had a purpose for being here. That wasn't the first time it was here, and it probably won't be the last time.

167

So there is a reason for it being here. Is it here for food? Possibility.

168

Is it here to monitor these rocket launches that we have a possibility?

169

All right. Well, you give me a lot to think about.

Now I've got to kind of compile this and try to make sense of it.

So thank you so much for your time.

Have there been other sightings like trishes that have caused witnesses to feel threatened?

To find out, Ben decides to research the historic archives of Project Blue Book,

179

and Mark O'Connell has offered to lend his expertise.

180

Hey, Mark.

Hey, Ben.

182

So I've been down in Florida looking into this case of Trish Bishop.

183

Now Trish claims that in her own backyard, she had a very terrifying encounter.

184

Okay, I guess what we call a close encounter of the third kind.

185

There was this craft that came down in a wooded area,

186

00:13:25,000 --> 00:13:32,000

and as she watched from the corner of her house, she saw this massive figure.

187

00:13:33,000 --> 00:13:38,000

At first she thought it was a human, except that as she kept watching this thing,

188

00:13:38,000 --> 00:13:48,000

she quickly realized that the eyes, the mouth, and jawline, and everything was definitely not human.

189

In fact, it's quite terrifying.

190

00:13:50,000 --> 00:13:58,000

She kind of took some photo editing and created the best version of what she believed she saw.

191

So Trish is like, what just happened here is there's something that is visiting or living in the woods?

192

And I'm wondering if there are any other stories in the Blue Book era

193

where people have been so impacted by a close encounter of a craft

194

00:14:17,000 --> 00:14:21,000

and occupants maybe even in their own backyard?

195

00:14:21,000 --> 00:14:26,000

There is a case that fits the bill, what you're talking about.

196

00:14:26,000 --> 00:14:33,000

It took place in 1955 when it involved a farm family that was besieged by strange creatures.

197

00:14:33,000 --> 00:14:39,000

It was a terrifying incident, but it wasn't just terrifying, it actually became quite violent.

198

00:14:39,000 --> 00:14:41,000

Wow.

199

00:14:56,000 --> 00:15:18,000

This family, after four hours of fighting off these creatures, they all pile into their trucks and

speed into town for them to police.

200

00:15:18,000 --> 00:15:20,000

These are people who take care of themselves.

201

00:15:20,000 --> 00:15:23,000

These are people who reach for their gun when there's trouble.

202

00:15:23,000 --> 00:15:25,000

They don't go to the police.

203

00:15:25,000 --> 00:15:30,000

So imagine you are the desk sergeant at the police department that night.

204

00:15:30,000 --> 00:15:37,000

11 o'clock at night, two pickups come racing into the parking lot, skidding to a stop.

205

00:15:37,000 --> 00:15:46,000

Eleven people go inside and report that a UFO, a flying saucer has landed behind their house and that they've been attacked by little creatures.

206

00:15:47,000 --> 00:15:56,000

16 law enforcement officers, the local police, the county sheriff, the state police, they all send people to the farm to see what they can find.

207

00:15:56,000 --> 00:16:00,000

And they find lots of evidence that the shootout really happened.

208

00:16:00,000 --> 00:16:08,000

There are holes in the screens, they're shot embedded in the window frames, their shell casing scattered all over the ground.

209

00:16:08,000 --> 00:16:17,000

And one more piece of evidence was that there was a bald spot in the grass in the gully behind the farmhouse.

210

00:16:20,000 --> 00:16:28,000

Now this is where Billy Ray had first seen the object float down from the sky and land on the ground.

211

00:16:28,000 --> 00:16:32,000

There was a bald patch there that nobody ever investigated.

212

00:16:32,000 --> 00:16:43,000

Well that's something to follow up on, definitely. Anything that could possibly be still there as far as physical evidence, because it sounds like military, the law enforcement botched it.

213

It just raised too many tough questions, questions they just didn't want to deal with.

But you're telling me the police took it seriously, they came there yet, they didn't really do an investigation.

The military shows up, what did the military conclude? Was the Air Force or Blue Book then involved after this?

The Air Force's involvement in this case is totally schizophrenic. They were all over this case, but publicly they had no interest.

Wow.

In addition, and this is what the Air Force doesn't want you to remember, in addition there were four military policemen from Fort Campbell, which was about 20 miles away.

219

They were there almost instantly. There were also two men, two agents from a government agency that was never named, but they were wearing civilian clothes.

220

00:17:36,000 --> 00:17:46,000

But these two men showed up the day after the sighting and started asking a lot of questions. Nobody knows who they were, nobody knows who they represented or who they worked for.

221

But they were on the scene asking questions. So it's just one more layer of government involvement that they were desperately trying to cover up.

222

Well, once again, we might have a possible connection with the military base nearby, right? I don't know what they were doing at Fort Campbell at the time, but Trish Bishop in Florida has a view of some of the rocket launches, the shuttle launches, and things that happen at Cape Canaveral.

223

It's something to look at that perhaps there's a connection to the activity happening at Fort Campbell. Is there any way that I could talk to anyone who might be related to the family still?

I think you could talk with Geraldine Sutton. She's the daughter of Lucky Sutton, who was kind of the main witness in the alien invasion case. She wasn't alive at the time it happened, but she's heard the stories from her family about that incident. I think you could learn a lot from her.

Oh, I would absolutely love that, and especially because this is such a fantastical story, she would be the one to get the details from.

I'm on my way to Kelly, Kentucky. The Sutton family encountered something quite freakish. The description of these creatures is so strange, but in a way it's similar to what Trish reported.

Hey, Geraldine.

Hey, Ben.

Nice to meet you. Good to meet you. You too. You too. So this is it, huh?

237

This is the great community of Kelly, Kentucky. Wow. Wow. I don't imagine much has changed, has it?

238

No, not really. Past that house right there. It was just filled in trees.

239

So Geraldine, tell me about that night. It was 1955. Who was there at this farmhouse and what happened?

Map of the Sutton farm showing fields and goalie.

360

The goalie where object is supposed to have landed about 300 feet from the house.

361

The house is here.

362

00:33:55,000 --> 00:33:58,000

300 feet or so back.

363

00:33:58,000 --> 00:34:00,000

Fence line, the farm.

364

00:34:00,000 --> 00:34:08,000

This is quite detailed because they've taken the time to create the topography and the elevation lines here.

365

00:34:08,000 --> 00:34:13,000

You can see that this depression is about a 30 foot goalie.

366

00:34:13,000 --> 00:34:20,000

That's where they believe that the object supposedly landed.

367

00:34:20,000 --> 00:34:22,000

This is really cool.

368

Well, I think the next step is to actually get out there.

369

Get out there to the location and see if this is at all like it used to look like back at that time period and to talk.

370

To Geraldine.

371

00:34:44,000 --> 00:34:53,000

So if this craft had mechanical problems and if this is still a very rural area, it is possible that there's something that had been overlooked.

372

While the government claimed there was no official investigation into the Sutton case, Bill's account says otherwise.

Okay. Do you mind kind of walking me through the different parts of the property and things that we can still see?

If any evidence of the landing remains, it should be around that part of the woods.

Well, that's about 300 feet. So from the back to the house right here, yeah, it matches up with the map.

Geraldine has located a clearing in the woods without any old growth trees. Could this have been where the craft landed?

425

Well, these are definitely new trees. I think we're in it. Hold on. Are you seeing what I'm seeing?

426

00:40:30,000 --> 00:40:35,000

This is a patch of bare earth that looks a lot like what Bill described.

427

It looked like somebody had literally shaved the grass off to clay.

428

The circular patch of exposed soil doesn't match anything in its surroundings.

429

00:40:46,000 --> 00:40:53,000

And Ben can find no sign of what could have caused such an odd circle to form here naturally.

430

Ben believes he could have found the location of the UFO's alleged landing.

431

Now he wants to scan the old growth trees in the area.

432

00:41:04,000 --> 00:41:10,000

If this was the direction the Sutton's were shooting, bullets might still be embedded in the trees.

433

These trees should have no metal in them unless somebody shot them.

434

Oh! What was that?

435

Incredibly, Ben detects signs of metal in the trees, potentially bullets covered by decades of growth.

Between the discovery of the depression, the cleared ground, and the positive scans on the trees, the Sutton story could be plausible.
