COOFOAS is a private organization founded by Dr. Heineck, with a goal of scientifically analyzing the world's UFO sightings.

UFO historian Mark O'Connell is meeting me here to help me with my research.

So, as you know, I was in Northern California.

You may have noticed that I pulled out a second file just now.

You may have heard of this one too, the Pascagoula Mississippi Abduction Case from 1973.

I've heard the name. I honestly don't know anything about it.

176

00:14:25,000 --> 00:14:36,000

It ties in with everything we've just been talking about, about potentially hostile aliens conducting very aggressive medical exams on abductees.

177

On the evening of October 11th, 1973, outside of Pascagoula, Mississippi, 42-year-old Charles Hickson and his co-worker, 19-year-old Calvin Parker, were taken onto an alien craft.

178

What I do have is an audio recording of an interview Charles Hickson did later after the abduction.

179

00:14:58,000 --> 00:14:59,000

Oh, okay.

180

00:14:59,000 --> 00:15:01,000

It's less listen to that.

181

00:15:01,000 --> 00:15:10,000

I kept thinking, you know, what are they going to do? Are they going to take us away? Or are they going to kill us?

182

00:15:10,000 --> 00:15:16,000

And when they carried me aboard that craft, I figured that I'd never put my foot on Earth again.

183

That I'd never see my family anymore.

184

00:15:19,000 --> 00:15:21,000

And what's the problem with them?

185

They don't exist. Well, what's got to happen?

186

There's 200 million people got to see a UFO before it's firmly believed.

187

Pascagoula Abduction makes national headlines.

188

00:15:37,000 --> 00:15:42,000

And Heineck shows up, I think, about two days after the event took place.

189

Now, Dr. Heineck was never very comfortable with abduction cases.

190

00:15:48,000 --> 00:15:51,000

It just raised too many weird questions that he couldn't answer.

191

00:15:51,000 --> 00:15:59,000

After arriving in Pascagoula, Dr. Heineck was given a secret recording made of Calvin and Charlie during their interrogation.

192

This is what he heard.

193

00:16:18,000 --> 00:16:34,000

It makes sense that if this was a real event and you leave the room, you're still going to be talking about it.

194

Yeah, you can hear the adrenaline in their voices, you know.

195

00:16:38,000 --> 00:16:45,000

Heineck came out of that hypnosis session, a changed man. Just listen to what he has to say on this tape.

196

I went down to Pascagoula completely negative, but I worked with those men for quite a while.

197

I listened to tapes that had been taken when they didn't know they were being taped.

198

I saw how Charlie behaved under hypnosis, and all of those things convinced me that he was not making it up.

199

They had had an experience, period.

200

00:17:12,000 --> 00:17:18,000

That sounds just like Heineck. He doesn't say, I know that they were abducted.

201

00:17:18,000 --> 00:17:23,000

He says, I'm convinced, however, that they had a real experience.

202

00:17:23,000 --> 00:17:30,000

The first thing that Calvin, Parker, and Charles Hixon did after their abduction was to call the sheriff.

203

Well, the sheriff, Sheriff Fred Diamond, and Hixon and Parker themselves were worried that they may have been exposed to radiation.

204

This is what precipitated the sheriff's deputy to drive Parker and Hixon to the Air Force Base to be examined in the infirmary for radiation exposure.

205

Well, they were examined.

Did they have any marks?

207

00:17:55,000 --> 00:17:59,000

Yeah, in fact, there's a report on it right here in the file.

Puncture marks noted on Charles Hixon and Calvin Parker.

209

00:18:03,000 --> 00:18:13,000

Approximately 72 hours after their abduction, certain markings were found on their bodies of which both men could not account for their presence when questioned about them.

There's a lot of similarities between these three cases.

211

The Pasquibur case of 1973 harkens back to the Hill case of 1961, because in both cases, the government attempted to mislead or cover up any evidence of the encounter.

In the case of Rob Follington, could the government's new strategy be to just ignore the facts entirely?

213

I've recently been in touch with Calvin Parker. I think you should go talk to him.

There's something very, very fishy about the way this whole thing played out with the Air Force. It just doesn't add up.

I'm in Pascagoula, Mississippi, and I'm here to meet with Calvin Parker, who was involved in the 1973 UFO abduction case.

Thank you, thank you.

Wynet. Pleasure to meet you as well.

224

Calvin's wife, Wynet, has avoided the cameras since the abduction. However, she's agreed to make an exception for Ben.

225

So this is how long you lived here?

226

Since right after Katrina, never would use my real name to my neighbors.

227

Really?

They didn't find out who I was till last year.

229

Are you serious?

230

I am dead serious.

How long did you use the other name for?

232

45 years.

233

45 years?

234

00:19:59,000 --> 00:20:00,000

Wynet, is it?

235

00:20:00,000 --> 00:20:01,000

Yes.

236

00:20:01,000 --> 00:20:07,000

So you, I understand, were with him from the beginning. You were engaged when this happened.

237

We were engaged, uh-huh.
