They didn't send anyone out to investigate and then they said that the witnesses were not available, but they absolutely were available.

And so nobody, wow, no one tried contacting them in person?

427

I'm very interested in the physical evidence and I understand that you still have access to some of these things.

I do. There's an archival collection at the University of New Hampshire. So let's go down and take a look.

So this is the original dress.

We have here some of the real prize documents. These are Barney's drawings of the craft itself.

443

When he and Betty returned home, this is what he recalled observing.

Wow. I think it's great that they decided to make these right after. You know, to remember as much as he could.

445

Did you see a very significant change with your aunt and uncle after that?

446

Well, I saw my aunt and uncle once or twice a week. We had a very close relationship and there was absolutely a change in their behavior.

Betty became obsessed with what happened. She wanted to find answers and Barney just wanted to forget about it.

450

Yes. Betty did take a lie detector test and passed it with no evidence of deception.

This is critical evidence. Just like Geraldine Arrozco, Betty passed a polygraph proving she truly believed the story of her abduction.

Three stains.

Three very big stains.

Wow.

482

Kathleen, if you don't remember seeing or hearing about this being tested, this is pretty significant.

483

What could that be?

Look at this.

But it's on the lining. It's not on the dress.

486

So it's just on the lining.

I'm not seeing it yet.

489

I mean, if it came from the outside, you would see it more defined on the outside of the dress rather than the slip itself.

Okay, so I've got waist here.

491

It's a high-waisted belt.

492
