Kenneth Arnold was an experienced pilot.

There had been a missing aircraft that the military

43

had put a reward out for.

And he thought, I'll go out and I'll take a look.

45

It's at this critical point in time that the modern age

46

And this was a day where there was good clear visibility.

And what Kenneth Arnold saw was nine strange objects

He had the presence of mind to attempt to measure

and calculate their distance and speed.

He knew the distance between two particular peaks

59

in the mountain range where he was,

and he was able to time it.

At first, he thought maybe the speed was 1,200 miles per hour.

But then later, it was calculated to be nearly 1,650 miles.

This was three times faster than any plane

The Kenneth Arnold encounter is not only iconic,

67

but it's also really revealing,

68

because this is the first time in the post-war era

69

that we really have something that we could probably say

70

is of possibly extraterrestrial origin.

We're looking at a technology that appears to be far more advanced

72

than anything we had at that time.

The next day, Arnold talks to the press,

74

and the incident gains explosive nationwide news coverage.

It's the first-ever credible sighting of UFOs over the United States.

And thanks to Arnold's description,

the term flying saucer is born.

When Kenneth Arnold related the experience,

79

he was asked by one of the reporters,

80

how did these objects move?

81

And he used the analogy he said, like a saucer would,

82

00:05:08,980 --> 00:05:11,980

if you skipped it across water.

83

Now, the media got hold of that,

84

00:05:13,980 --> 00:05:16,980

and they used the term flying saucer.

85

00:05:16,980 --> 00:05:20,980

And in some quarters, that led to a misperception

86

that Arnold had seen a saucer-shaped object,

87

00:05:24,980 --> 00:05:27,980

when, in fact, it was more delta-shaped.

88

People really forget what a great witness Kenneth Arnold actually was.

89

He was a private pilot in his 30s,

90

00:05:35,980 --> 00:05:39,980

and to everybody who knew him, he was a solid guy.

91

Arnold's claim gains even more traction

92

when two eyewitnesses to the same sighting come forward.

93

The sighting was corroborated by a prospector on Mount Adams

who saw these things.

He claimed to see six of these objects on the same day at the same time.

And then there was a forestry service worker on Firewatch

He also said the objects appeared to move in a straight line.

After a few weeks, Arnold submits a letter to Air Force Intelligence

Kenneth Arnold made a detailed report

and he included description

Well, the military did an investigation,

106

and they simply dismissed the whole thing and said it was a mirage.

and he came out of his house with his camera,

expecting to get a photo of a jet.

And to his amazement, he saw the strange craft in the sky.

He managed to get two photographs.

120

And subsequently, the media published these with a story saying

here is photographic evidence of these so-called flying saucers.

Rhodes offers his photographs to the Arizona Republic,

and he said, that's exactly what I saw.

And when he calls the FBI, they deny all knowledge of the incident.

Was this to destroy the evidence of UFOs?

135

And is there a connection to sensational news of a UFO crash

136

Reported the day before Rhodes' pictures were published.

150

It's a successful effort,

153

except in the rare instance when a sighting is captured on film.

154

Case in point, July 1952.

155

July 2nd, we have a naval warrant officer,

156

00:10:05,980 --> 00:10:08,980

a man named Delbert C. Newhouse.

157

And he's just traveling with his family.

158

00:10:10,980 --> 00:10:12,980

They're on a little trip in Utah.

159

00:10:12,980 --> 00:10:15,980

And I believe his wife is the first one to see

160

00:10:15,980 --> 00:10:17,980

what looked like very unusual objects in the sky.

161

Delbert Newhouse was a Navy officer,

162

00:10:20,980 --> 00:10:22,980

but not only that, he was a photographer.

163

00:10:22,980 --> 00:10:26,980

He and his wife were going through Tremont in Utah

164

00:10:26,980 --> 00:10:28,980

when they noticed something unusual.

165

00:10:28,980 --> 00:10:30,980

He stepped out of the car,

166

00:10:30,980 --> 00:10:34,980

grabbed his camera, and started filming.

167

00:10:34,980 --> 00:10:36,980

Newhouse quickly records what will become

168

00:10:36,980 --> 00:10:39,980

the first ever filmed evidence of UFOs.

169

00:10:39,980 --> 00:10:42,980

Never before seen on national television,

170

00:10:42,980 --> 00:10:46,980

the film shows numerous unknown objects high in the sky.

171

00:10:48,980 --> 00:10:51,980

Now, the film is quite damaged,

172

00:10:51,980 --> 00:10:55,980

but when you freeze it and advance it frame by frame,

173

00:10:55,980 --> 00:10:58,980

you can get a real good look at the fact that there are,

174

indeed, multiple objects in the sky.

175

Newhouse claimed that he saw 12 of these objects.

176

00:11:16,980 --> 00:11:19,980

Kenneth Arnold, back in 1947,

177

00:11:19,980 --> 00:11:24,980

saw nine objects flying, apparently, in formation.

178

00:11:24,980 --> 00:11:29,980

In both instances, these were apparently shiny,

179

00:11:29,980 --> 00:11:32,980

probably metallic, craft.

180

00:11:32,980 --> 00:11:34,980

Kenneth Arnold was a pilot.

181

00:11:34,980 --> 00:11:37,980

Newhouse had 2,000 flying hours,

182

00:11:37,980 --> 00:11:41,980

and he was an experienced Navy photographer.

183

00:11:41,980 --> 00:11:47,980

These are expert witnesses reporting extraordinary sightings.

184

00:11:47,980 --> 00:11:50,980

Is it possible that Delbert Newhouse and Kenneth Arnold

185

00:11:50,980 --> 00:11:54,980

were seeing the same UFOs, but years apart?

186

00:11:54,980 --> 00:11:57,980

It's a tantalizing question.

187

00:11:57,980 --> 00:12:00,980

It's impossible to know exactly what these objects were

188

00:12:00,980 --> 00:12:02,980

and where they might have come from.

189

00:12:02,980 --> 00:12:04,980

However, the fact that they were noticed,

190

00:12:04,980 --> 00:12:06,980

that they were considered extraordinary,

191

00:12:06,980 --> 00:12:10,980

is that there is some sort of mysterious origin to them.

192

What's really quite interesting to me is that that film

193

was studied at great length by the United States Navy

194

00:12:19,980 --> 00:12:22,980

and the United States Air Force independently

195

during the summer and fall of 1952.

196

And the conclusion was not balloons, not birds,

197

00:12:28,980 --> 00:12:32,980

not anything conventional that anyone was able to come up with.

198

This unknown aerial objects were nothing that they could identify

199

00:12:36,980 --> 00:12:38,980

in any logical way.

200

00:12:38,980 --> 00:12:41,980

Even so, four years later,

201

00:12:41,980 --> 00:12:44,980

the Air Force publicly endorses an explanation

202

00:12:44,980 --> 00:12:48,980

that the filmed objects were birds.

203

00:12:50,980 --> 00:12:52,980

A lot of people have tried to dismiss these videos

204

00:12:52,980 --> 00:12:55,980

as being flocks of birds, but that seems extremely unlikely

205

00:12:55,980 --> 00:12:57,980

because birds don't actually fly like that.

206

00:12:57,980 --> 00:12:59,980

I mean, that's to be serious.

207

That's a very weak explanation.

208

It's a curious conclusion, say UFO investigators

209

who believe the Newhouse film,

210

William Rhodes' Photos,

211

at Kenneth Arnold's Eyewitness account,

212

00:13:10,980 --> 00:13:13,980

are convincing evidence of extraterrestrial spacecraft

213

visiting our world.

214

So why does the U.S. military dismiss such claims

215

and reject what many say proves the existence of UFOs?

The military needs to project power, not confusion.

222

for a military to maintain maximum control

over the formulation of this problem

225

from a public relations point of view.

But what about a sighting decades later

227

federal authorities receive reports that nearly 12 airport employees

232

are witnessing a metallic, sunscre-shaped craft

233

00:14:35,980 --> 00:14:39,980

hovering over United Airlines' gate C-17.

234

00:14:40,980 --> 00:14:46,980

Multiple witnesses claim that they saw something unusual.

235

00:14:46,980 --> 00:14:51,980

These witnesses included some mechanics, some pilots,

236

00:14:51,980 --> 00:14:53,980

and then there were conversations going on

237

00:14:53,980 --> 00:14:57,980

between some of these United Airlines employees

238

00:14:57,980 --> 00:15:02,980

and federal aviation administration officials and supervisors.

239

00:15:03,980 --> 00:15:07,980

Initially, United Airlines and the Federal Aviation Administration,

240

00:15:07,980 --> 00:15:11,980

or FAA, deny any knowledge of the event.

241

00:15:13,980 --> 00:15:16,980

They say radar found nothing out of the ordinary.

242

00:15:16,980 --> 00:15:19,980

But strangely, after their initial statements,

243

00:15:19,980 --> 00:15:22,980

United Airlines prohibits its employees

244

00:15:22,980 --> 00:15:26,980

from discussing the matter further with the media.

245

00:15:26,980 --> 00:15:28,980

What we now know, without any question,

246

00:15:28,980 --> 00:15:30,980

is that all of those employees were told,

247

00:15:30,980 --> 00:15:33,980

you are not to talk about this.

248

00:15:34,980 --> 00:15:35,980

But one person did.

249

00:15:35,980 --> 00:15:38,980

One person wrote about this anonymously

250

00:15:38,980 --> 00:15:41,980

to the National UFO Reporting Center on the web.

251

00:15:41,980 --> 00:15:44,980

And that's how the story actually got out.

252

Travel journalist for the Chicago Tribune, John Hilkovich,

253

00:15:48,980 --> 00:15:50,980

he thought, hey, you know what?

254

00:15:50,980 --> 00:15:52,980

I'm going to follow up on this.

255

00:15:52,980 --> 00:15:55,980

And he does, on National Public Radio.

256

00:15:55,980 --> 00:15:57,980

John Hilkovich, thanks for being with us.

257

00:15:57,980 --> 00:15:58,980

You're welcome.

258

00:15:58,980 --> 00:16:00,980

He confirms that United Airlines employees

259

00:16:00,980 --> 00:16:03,980

had seen something from out of this world.

260

00:16:03,980 --> 00:16:05,980

They all tell a very similar story

261

00:16:05,980 --> 00:16:08,980

from different vantage points at the airport.

262

00:16:08,980 --> 00:16:14,980

And they saw this gray metallic object just below the cloud layer.

263

00:16:14,980 --> 00:16:16,980

And this object was stationary,

264

00:16:16,980 --> 00:16:19,980

but standing there for some minutes.

265

00:16:19,980 --> 00:16:21,980

The eyewitness accounts are enough for Hilkovich

266

00:16:21,980 --> 00:16:25,980

and the Chicago Tribune to continue in pursuit of the truth.

267

And what they uncover is stunning evidence

268

00:16:28,980 --> 00:16:30,980

of what really happened.

269

Coming up.

270

The picture clearly shows a structured craft

271

that doesn't conform to any known demand.

272

Every time we have these credible sightings,

273

we seem to get this debunking from the government.

274

UFO experts say that the US military and government agencies

275

have been concealing what they know about UFOs since the 1940s.

And now, officials from United Airlines and the FAA

277

say that nothing unusual occurred at O'Hare Airport

278

on November 7th, 2006.

279

But might the evidence prove otherwise?

280

The number of people had actually managed to capture photographs

281

of this strange object.

And apparently there were gasps of astonishment

He said he had perfect visibility of 10 miles and a practical visibility of up to 50 miles.

This thing was out of visibility in two seconds.

On his highly sophisticated radar, he was able to see the object, and when radar locked onto it, it responded.

And in a period of only two seconds, it drops about 9,000 feet.

This is an incredible object that had performance that's off the charts.

499

As Fraver often was quoted to say, I don't know what it was, but I'd sure like to fly it.

In his testimony, Pilot Fraver states,

I can tell you, I think it was not from this world.

When someone like David Fraver, who is an experienced military pilot with two decades of experience,

504

says that what he's witnessing is not of this world, then you have to take that seriously.

505

Even if some in the UFO community remain suspicious, they believe the Pentagon could be releasing these videos to prepare us for something even more profound.

Details of how exactly Bob Bigelow is involved with the Pentagon's program, some say, are nothing short of explosive.
