Well, the first thing we did was run outside and look and see if there really was something in the sky and there was a white light.

174

And there were colored lights kind of rotating around it. There was red, green, blue, purple and gold colored light.

175

And they were flashing systematically.

176

00:15:41,000 --> 00:15:46,000

It was very shallow like two shallow saucers placed together.

177

00:15:46,000 --> 00:15:54,000

The only lights on it were on the bottom. In the center was a recessed amber light.

A Post Falls local shot this compelling videotape.

179

00:16:04,000 --> 00:16:14,000

It shows one of the crafts in the sky. In order for the camera to pick up the object, the light emanating from it would have to be unusually bright.

Not far away, near Lake Newman, a man was almost blinded by an unearthly light.

Well it looked like an airplane. It was that big.

Then the Air Force arrived.

The next thing I know, here come this guy from the Air Force.
