The Allagash Abduction is an absolutely fascinating case.

This involved four men out fishing.

The four artist friends, including Chuck Rack,

make a fire on shore to serve as a beacon for their nighttime fishing.

Missing time is a classic symptom of alien abduction.

they realize that there's a big chunk of time

that they just simply can't account for.

And that's what you call missing time.

Afterwards, they began to have flashbacks,

68

dreams, nightmares.

They went for regression hypnosis.

70

And what emerged was an account

71

that they were taken on board this ship.

Hypnosis is still heavily debated among UFO researchers

73

and scientists as a tool to investigate close encounters

74

and buried memories of traumatic experiences.

Hypnosis is the process of putting somebody

76

into a very relaxed state.

77

And what that means is they're not only very subjective

78

to maybe memories being implanted in them,

79

but it also kind of brings their walls down.

If they have memories that they have forgotten.

81

During the Allagash Hypnosis sessions,

82

the men begin to recall an intense and vivid encounter

83

with several aliens who allegedly took them aboard a UFO.

They saw strange entities, humanoid, but clearly not human,

85

00:04:42,960 --> 00:04:46,960

and that, again, some medical procedure,

86

which is often so central to these alien abduction experiences,

87

was carried out.

88

But skeptics point out that there are many key similarities

89

to alien abduction that may be the result of auto-suggestion.

90

People literally report that they are floated into the craft somehow,

91

often through the solid surfaces, through walls, through ceilings,

92

through the hull of the ships themselves.

93

Often, after that, they find themselves in an enclosed space of some sort.

94

Often this is reported as quite sterile and white in colour.

95

Skeptics hold up these common descriptions

96

as reasons to doubt UFO abduction testimony.

But if many of the descriptions are all similar,

98

could it also be the truth?

There are frequent reports of a table or a raised platform

100

in the centre of what's often described as a fairly round,

101

but otherwise featureless space.

When you listen to stories of abductions and the settings

103

that they will recollect, some of them, and most of them,

104

will actually remember being in some type of medical room,

105

medical examination room with equipment around and their abductors above them.

But you have to assume that that's not the only part of the ship.

107

This was a case of a couple returning home late at night,

108

driving down the archetypal lonely country road near Exeter, New Hampshire.

Betty and Barney Hill were driving down the highway when they witnessed a UFO.

110

The couple initially describes the craft as multi-coloured lights flashing across the moon.

The UFO rapidly descends and Barney stops their car in the middle of the highway.

112

A huge, silent, disc-shaped craft hovers in front of them.

113

Using binoculars, Barney claims to see 11 humanoid figures

114

00:07:13,960 --> 00:07:16,960

staring out of the row of windows.

115

And as the craft then hovered over their car, cast a big light down on them.

116

Fearing for their lives, the couple jumps back down the road

117

00:07:26,960 --> 00:07:30,960

The couple jumps back in their car, but are pursued by the UFO.

118

00:07:30,960 --> 00:07:36,960

The next thing they know, they wake up 35 miles farther down the road.

119

This was a route and a journey that they were familiar with.

120

So what happened in that period of so-called missing time?

121

Despite the shared incident, Betty and Barney Hill try to return to normal.

122

An under-regression hypnosis outcome an account that it wasn't just a distant sighting of a UFO,

123

but this thing actually landed and they were forcibly taken onto the craft.

124

Under hypnosis, the Hills recount harrowing stories.

125

The medical examinations, the abductors looming over them, taking bodily fluid and samples.

126

They both recollected this and you've got to ask, well, what really happened to Betty and Barney Hill?

127

Barney Hill claims the aliens were almost human and that they took him to a small examination room

128

00:08:27,960 --> 00:08:30,960

and placed him on a rectangular table.

129

00:08:30,960 --> 00:08:35,960

Firstly, it does appear that a lot of this is quite functional.

130

00:08:35,960 --> 00:08:38,960

It's minimalistic, it's sterile.

131

If people report a medical procedure or physical examination,

132

00:08:44,960 --> 00:08:49,960

the parallels with our own operating theatres are quite interesting.

133

But the similarities don't end there.

134

There are also motifs, I believe, that one can recognise from science fiction

135

and of course the relationship between sci-fi and ufology is complex.

Skeptics say abductees borrow from sci-fi, other people say it's the other way around.

137

But during Betty Hill's therapy, she reports that the human-like aliens scraped her skin with a knife.

They also pierced her with a needle and she even held a book written in a language she did not recognise.

But what are the abductees really seeing?

140

And why, despite the traumatic events, are their surroundings eerily familiar?

141

One phenomenon that's been noted with a lot of the abduction reports

142

is what's called cultural tracking.

143

The idea that the technology the abductees report is almost just a little bit ahead of us, our own technology.

144

But not so far ahead of us that it's indistinguishable.

145

A viewing screen is obviously a viewing screen.

146

00:10:00,960 --> 00:10:05,960

A computer does seem to be a computer even though it's different in some respects from our own.

147

00:10:05,960 --> 00:10:08,960

So there's a sort of familiarity here.

148

00:10:08,960 --> 00:10:13,960

Which may explain why experiencers and abductees who are in different parts of the world

149

00:10:13,960 --> 00:10:18,960

that experience different abductors with different physical features,

150

00:10:18,960 --> 00:10:22,960

why the ships themselves are different as well.

151

With so many common similarities across many abductee reports,

152

the question remains, is alien abduction testimony merely a fabrication?

153

Or is it an attempt to make sense of something beyond human comprehension?

154

Many abductees who have allegedly witnessed the inside of a UFO

155

report surroundings of a strangely familiar yet advanced technology.

156

But one man's now famous encounter describes something much more.

157

A mothership.

158

00:11:00,960 --> 00:11:02,960

Unsealed case file.

159

00:11:02,960 --> 00:11:05,960

The Travis Walton Abduction.

160

00:11:05,960 --> 00:11:08,960

November 5th, 1975.

161

00:11:08,960 --> 00:11:11,960

Apache Sitgreaves National Forest, Arizona.

162

00:11:11,960 --> 00:11:15,960

Travis Walton is employed on a logging crew in Arizona.

163

00:11:15,960 --> 00:11:19,960

After his shift ends, the crew drive back to camp.

164

00:11:19,960 --> 00:11:22,960

When a bright light appears just off the road,

165

00:11:22,960 --> 00:11:25,960

Travis decides to get a closer look.

166

00:11:25,960 --> 00:11:30,960

Now Travis Walton was a bit of an extrovert, a bit of a daredevil.

167

00:11:30,960 --> 00:11:37,960

And while all his friends and work colleagues were screaming at him to get back in the truck,

168

00:11:37,960 --> 00:11:41,960

Travis Walton actually walked towards this UFO.

169

00:11:41,960 --> 00:11:45,960

Almost like he was challenging it, like quite aggressively.

170

00:11:45,960 --> 00:11:50,960

But suddenly, Walton is engulfed by a beam of light coming from the UFO.

171

00:11:50,960 --> 00:11:53,960

And he disappears from view.

172

00:11:53,960 --> 00:11:56,960

At this point, he was struck by a beam.

173

00:11:56,960 --> 00:12:02,960

And it literally took him off his feet, through him, through the air.

174

00:12:02,960 --> 00:12:06,960

And his colleagues thought that he had been killed.

175

00:12:06,960 --> 00:12:13,960

Walton's coworkers drive away in a panic and later report his disappearance to the local sheriff.

176

00:12:13,960 --> 00:12:18,960

But five days after the incident, Walton's brother-in-law receives a call.

177

00:12:18,960 --> 00:12:26,960

Travis Walton himself turned up some days later, disorientated, dishevelled,

178

00:12:26,960 --> 00:12:32,960

miles away with little recollection of what had happened to him.

179

00:12:32,960 --> 00:12:39,960

It was only later, under regression hypnosis, that a fuller story emerged.

180

00:12:39,960 --> 00:12:45,960

Travis tells a terrifying story of being subjected to invasive medical examinations

181

00:12:45,960 --> 00:12:47,960

and extended confinement.

182

00:12:47,960 --> 00:12:56,960

Over the years, Travis Walton has agreed to sit a number of polygraph tests.

183

00:12:56,960 --> 00:13:01,960

Now again, if somebody was lying or had something to hide,

184

00:13:01,960 --> 00:13:05,960

I suspect he would have avoided putting himself in that position.

185

00:13:05,960 --> 00:13:10,960

If alien abduction is truly happening, what do the abductors want?

186

00:13:10,960 --> 00:13:17,960

If an intelligent civilization comes here and sees an incredibly inferior race,

187

00:13:17,960 --> 00:13:21,960

and their question is, how did the human race get there?

188

00:13:21,960 --> 00:13:26,960

How did this life form that has made these big buildings and they drive around in these cars,

189

00:13:26,960 --> 00:13:29,960

how did they come to be? Well, what are they going to do?

190

00:13:29,960 --> 00:13:34,960

We could probably safely assume they're going to do the exact same thing we would and experiment.

191

00:13:34,960 --> 00:13:39,960

While Walton's claims of a medical exam are a common thread among abductees,

192

00:13:39,960 --> 00:13:44,960

it is his description of the inside of the ship that defies explanation.

193

00:13:44,960 --> 00:13:55,960

He talks about multiple rooms and he seems to have had some freedom at some point to move around within the interior.

194

00:13:55,960 --> 00:14:01,960

He saw, for example, one space which he almost likened to a planetarium.

195

00:14:01,960 --> 00:14:06,960

Walton describes a domed room with what seems to be a control chair in the center.

196

00:14:06,960 --> 00:14:10,960

He sat in this thing, there seemed to be some sort of controls.

197

00:14:10,960 --> 00:14:15,960

He played around with them and it was almost like the, like you see in a planetarium,

198

00:14:15,960 --> 00:14:18,960

where stars appear on the ceiling.

199

00:14:18,960 --> 00:14:25,960

Now he figured it probably wasn't a good idea that he continued to play with these controls,

200

00:14:25,960 --> 00:14:30,960

but it's one of the rare instances we have in an abduction account

201

00:14:30,960 --> 00:14:35,960

of somebody actually getting to try out the technology for themselves.

202

00:14:35,960 --> 00:14:42,960

Walton is then escorted to another room in the spaceship that he claims is as large as an airplane hangar.

203

00:14:42,960 --> 00:14:50,960

He reports this as being a cavernous area where within the ship,

204

00:14:50,960 --> 00:14:55,960

there were all these smaller craft rather like the one that he was taken into.

205

00:14:55,960 --> 00:15:03,960

Walton witnesses multiple disk-shaped craft parked in the room that are each up to 60 feet in diameter.

206

00:15:03,960 --> 00:15:08,960

The intriguing parallel here is, I guess, the idea of an aircraft carrier.

207

00:15:08,960 --> 00:15:14,960

I mean, people talk in the UFO field with alien abductions about scout ships and mother ships.

208

00:15:14,960 --> 00:15:20,960

It's clear from Travis Walton that he was taken from a scout ship onto a mother ship.

209

00:15:20,960 --> 00:15:23,960

Are UFOs encountered on Earth?

210

00:15:23,960 --> 00:15:26,960

Merely the pathfinders for a colossal mothership?

211

00:15:26,960 --> 00:15:34,960

Again, if one considers Travis Walton's account of all these other spaceships

212

00:15:34,960 --> 00:15:38,960

just existing within one space in the larger ship,

213

00:15:38,960 --> 00:15:41,960

it gives you some sense of perspective here,

214

00:15:41,960 --> 00:15:45,960

tells you that the mothership must be huge.

215

00:15:45,960 --> 00:15:53,960

I mean, some alien abduction accounts talk about spaceships the size of strip miles and football fields.

216

00:15:53,960 --> 00:15:56,960

Clearly that's what Travis Walton was dealing with.

217

00:15:56,960 --> 00:16:00,960

When you look at the stories about the shape and the size and the color

218

00:16:00,960 --> 00:16:05,960

and the texture of the alien spaceships that these abductees are taken away,

219

00:16:05,960 --> 00:16:13,960

there just are a wide variety of species and types of craft or UFOs that are visiting us and are above our skies.

220

00:16:16,960 --> 00:16:23,960

Alien abduction evidence suggests that UFO motherships may be hiding in our orbit

221

00:16:23,960 --> 00:16:31,960

and sending scout ships to examine our planet and its various life forms, including the human species.

222

00:16:31,960 --> 00:16:37,960

But some experts maintain their actions and methods are not unlike our own.

223

00:16:37,960 --> 00:16:40,960

Now alien abduction tales are very hard to believe.

224

00:16:40,960 --> 00:16:42,960

It's a tough pill to swallow, don't get me wrong.

225

00:16:42,960 --> 00:16:46,960

But when you truly compare it and contrast it to the human race,

226

00:16:46,960 --> 00:16:53,960

to the science that we know that we've learned from, that we've developed in just the last hundred and fifty years,

227

00:16:53,960 --> 00:16:56,960

when you look at that, we're on the same path.

228

00:16:56,960 --> 00:17:02,960

There's absolutely no difference between these crazy stories that some like to dismiss as just being fantasy

229

00:17:02,960 --> 00:17:05,960

versus our science that we've already done.

230

00:17:05,960 --> 00:17:09,960

So I think we're just pretty much on a crash course for the same path.

231

00:17:09,960 --> 00:17:11,960

It's just a matter of who's going to do it first.

232

00:17:11,960 --> 00:17:21,960

In all of these abduction reports, what's really critically missing is some absolutely definitive corroboration.

233

00:17:21,960 --> 00:17:28,960

My witness testimony is important and when it's corroborated independently, that's evidentially significant.

234

00:17:28,960 --> 00:17:30,960

But what we really need is information.

235

00:17:30,960 --> 00:17:39,960

And I think it's only a matter of time that if abductees are truly experiencing these types of rides on an alien spacecraft,

236

00:17:39,960 --> 00:17:44,960

some of them are more joyous than others admittedly, but if they really are experiencing this,

237

00:17:44,960 --> 00:17:48,960

I think one day our digital technology will capture it.

238

00:17:48,960 --> 00:17:54,960

The extraterrestrials, if that's what we're dealing with, would only have to slip up once.

239

00:17:54,960 --> 00:18:00,960

And an abductee would only have to get lucky once and sneak something off the craft, and it's game over.

240

00:18:00,960 --> 00:18:07,960

And I look forward to the day when someone will manage to smuggle some artifact off a spaceship.

241

And when that day comes, abductees may end up being the ones to prove the existence of extraterrestrials once and for all.

242
