There's something magical about the Navarra Reservation.

11

The Navarra Reservation is 27,000 square miles, that being about the size of West Virginia.

I probably stood in places where no other man has probably ever stood.

13

It's hard to take that in and imagine.

14

Seeing that vastness of just remote areas seems like it's infinite.

If you look at the Navarra Reservation, the Navarra Police provide the public safety aspect over our communities.

16

And the Navarra Rangers provide enforcement and protection over all of the natural resources of the Navarra Nation.

Kind of modeling from the National Park Service Rangers.

18

The Navarra Rangers were formed in 1957.

19

The job of a Navarra Ranger involves working in forest fire areas, doing evacuations.

20

00:03:35,240 --> 00:03:44,240

We're doing search and rescue operations, you know, hanging on the end of a rope off a cliff in the middle of the night, looking for somebody that stuck down there.

21

When I look back at wanting to become a Navarra Ranger, it was really an exclusive club.

22

00:03:52,240 --> 00:03:58,240

They had a presence about them, and I remember wanting to be a part of that.

23

I met Stan, I spent about 1989, and we started working together quite a bit.

24

00:04:07,240 --> 00:04:14,240

We were co-swat team commanders for back country operations.

25

00:04:14,240 --> 00:04:23,240

We got to know each other pretty well. We've adopted each other as brothers.

26

00:04:23,240 --> 00:04:36,240

In 2000, our chief Ranger called us all in for a meeting because of a complaint that was lodged against the department for failing to investigate a Bigfoot case.

27

Right now in the United States, there's no mechanism to investigate these type of paranormal cases.

28

00:04:43,240 --> 00:04:47,240

It's just not built into any of our systems, so they're ignored.

29

00:04:47,240 --> 00:04:54,240

However, you have people out there who are absolutely terrified of whatever that happened to them.

30

And our chief Ranger, he said, from now on, these cases are going to be investigated.

31

And then he turned to me and Stan, and you two guys are going to get the major cases.

32

I think there were those Navarra Rangers that would not go anywhere near these kind of cases.

33

00:05:15,240 --> 00:05:22,240

Simply because within the Navajo culture, it's taboo to deal with it, approach it, talk about it.

34

00:05:22,240 --> 00:05:28,240

The reason John and I were chosen is that we grew up in both worlds.

35

00:05:28,240 --> 00:05:35,240

He was born in Oklahoma and raised there. I was born in Los Angeles and raised there.

36

00:05:35,240 --> 00:05:47,240

We're our part Navajo, but we didn't hold to the traditional beliefs that a lot of the Navajos did about being around those type of things.

37

00:05:47,240 --> 00:05:53,240

My immediate thought was, oh my goodness, we're going to be the X-Files.

38

00:05:53,240 --> 00:06:12,240

One of the first cases we worked was up along the San Juan River, where we had over 30 people report seeing a bigfoot, which is real unusual.

39

This is the place where the investigation started.

40

00:06:22,240 --> 00:06:25,240

What actually happened this morning?

41

00:06:25,240 --> 00:06:29,240

Coming down that highway right there, I thought a person was hitchhiking.

42

00:06:29,240 --> 00:06:33,240

But as I got a little bit closer, it wasn't a person.

43

00:06:33,240 --> 00:06:40,240

It was a tall, tall body with, it seemed like with hair all over because I didn't see like facial features or anything.

44

We would interview witnesses and we talked to some terrified people who didn't know what was happening.

45

00:06:51,240 --> 00:06:59,240

They saw something completely out of the ordinary and they wanted answers.

46

One of my grandsons seeing it right there, I don't know, it was a big, really tall.

47

00:07:05,240 --> 00:07:07,240

I don't want to come down here by myself.

48

00:07:07,240 --> 00:07:11,240

Well, we've had other investigations that have been similar.

49

00:07:11,240 --> 00:07:21,240

We've had reports of bigfoot stepping over corrals and taking sheep and stepping back over and walking off with them.

50

00:07:21,240 --> 00:07:35,240

We've had sheep that were killed by literally having the wool just ripped off its back, just like you grabbed it around the neck and just took it and tore it off.

51

Holy Christ. No way.

52

Does it make that work there?

53

00:07:45,240 --> 00:07:48,240

That's a big knuckle, man.

54

And interviewing people up and down the river.

55

We got a real feel that these occurrences had been going on for some time.

56

These bigfoot subscribe many times as being much taller than a man, 7 foot, 8 foot.

57

Very muscular.

58

00:08:10,240 --> 00:08:12,240

Wide shoulders.

59

00:08:12,240 --> 00:08:13,240

Built like a tank.

60

00:08:13,240 --> 00:08:15,240

With canine teeth.

61

00:08:15,240 --> 00:08:17,240

Smells like a wet dog.

62

00:08:17,240 --> 00:08:21,240

It's a large, huge, hairy beast.

63

00:08:26,240 --> 00:08:30,240

During that time, I had heard the name Brenda Harris.

64

She resided up along the San Juan River.

65

00:08:36,240 --> 00:08:40,240

This is where we used to live.

66

00:08:40,240 --> 00:08:42,240

Our mobile home was parked right here.

67

00:08:42,240 --> 00:08:47,240

And this is where we had some encounters that had happened.

68

00:08:50,240 --> 00:08:51,240

This was during the summertime.

69

00:08:51,240 --> 00:08:55,240

I had all the bedroom windows open, living room windows open.

70

00:08:56,240 --> 00:08:59,240

My husband had just left for work at 10.30.

71

00:08:59,240 --> 00:09:02,240

He was working at Graveyard Chef.

72

00:09:02,240 --> 00:09:08,240

About 30 minutes later, I heard something very heavy walking onto the porch.

73

And next thing I know, we started seeing the door knob turning.

74

00:09:22,240 --> 00:09:25,240

I unlatched the log.

75

00:09:25,240 --> 00:09:29,240

Once I clicked, I could hear that thing let go of the door knob.

76

00:09:29,240 --> 00:09:31,240

I was really scared.

77

00:09:31,240 --> 00:09:36,240

I swung the door open, and I just seen this thing standing in front of me.

78

00:09:37,240 --> 00:09:40,240

I was like, wow.

79

00:09:40,240 --> 00:09:42,240

That can't be what I think it is.

80

00:09:42,240 --> 00:09:44,240

That's huge.

81

00:09:44,240 --> 00:09:48,240

It was black, tall, and it was covered in hair.

82

00:09:48,240 --> 00:09:50,240

And it wasn't very muscular.

83

00:09:50,240 --> 00:09:53,240

It was like kind of scraggly looking.

84

00:09:53,240 --> 00:09:56,240

I couldn't believe what I was seeing.

85

00:10:00,240 --> 00:10:05,240

And it just darted off the porch, and it ran to the west.

86

00:10:07,240 --> 00:10:12,240

About 15 to 20 minutes later, this thing came back again.

87

00:10:12,240 --> 00:10:17,240

And it did the same thing, started turning the door knob.

88

00:10:17,240 --> 00:10:21,240

As soon as I turned the bedroom light on, it took off.

89

00:10:24,240 --> 00:10:27,240

This went on throughout the whole night.

90

00:10:27,240 --> 00:10:33,240

And then finally, when daybreak broke, I said, OK, well, let's go walk around the house.

91

00:10:39,240 --> 00:10:44,240

So about right in here was the back of my daughter's bedroom.

92

00:10:44,240 --> 00:10:47,240

And this is where we found a footprint.

93

00:10:48,240 --> 00:10:53,240

A little over 18 inches long and 4 inches wide.

94

This thing could have just tore the door open, but it didn't.

95

00:11:00,240 --> 00:11:02,240

I was trying to get in the house.

96

00:11:02,240 --> 00:11:04,240

It's still a mystery to me to this day.

97

00:11:09,240 --> 00:11:15,240

Brenda lives in an area with somewhere near 30 people reporting the same kind of activity.

98

00:11:17,240 --> 00:11:22,240

So we took a team of about six guys up along the San Juan River.

99

00:11:26,240 --> 00:11:29,240

We came out with foot track evidence.

100

00:11:30,240 --> 00:11:33,240

You got a 21-inch footprint with the toes showing.

101

00:11:34,240 --> 00:11:36,240

And the thing's got a 5-foot stride.

102

00:11:38,240 --> 00:11:41,240

If I was going to do a 5-foot stride, I'd be doing the splits.

103

00:11:42,240 --> 00:11:47,240

The path went along and hit a barbed wire fence where it stepped over.

104

00:11:47,240 --> 00:11:53,240

Caught in the fence in the barbed wire was a tuft of hair.

105

00:11:53,240 --> 00:11:57,240

And we collected that as part of the investigation.

106

00:11:58,240 --> 00:12:01,240

Several hairs put together.

107

00:12:02,240 --> 00:12:09,240

These were real small, but they did have the tag ends on them, which is what they need for DNA examination.

108

00:12:10,240 --> 00:12:17,240

The DNA analysis would have told what species or major group of species that it belonged to.

109

00:12:18,240 --> 00:12:21,240

But the report just said unknown carnivore.

110

00:12:22,240 --> 00:12:25,240

There's no identification for it in the DNA database.

111

00:12:26,240 --> 00:12:31,240

And that DNA database has animals from all over the world.

112

There was no explanation for that.

113

00:12:39,240 --> 00:12:45,240

When I started getting interested in this, I said, hey, let's get the camera and set it up.

114

So we set the camera up one night behind our home.

115

00:12:50,240 --> 00:12:56,240

We did pick up, to me, what looks like a small juvenile bigfoot, which is probably about this high.

116

00:12:57,240 --> 00:12:59,240

It's a little black figure.

117

00:13:00,240 --> 00:13:07,240

I don't know if it crawled to where the pool was, but this thing, to me, it looks like it boils up from the ground.

118

00:13:07,240 --> 00:13:11,240

It stands and it takes like a running sense and takes off to the west.

119

00:13:13,240 --> 00:13:15,240

Also, I do have some vocalizations.

120

00:13:16,240 --> 00:13:39,240

I started hearing different people within the area experiencing this bigfoot that's been coming around.

121

00:13:40,240 --> 00:13:43,240

This is where the horse corrals stood.

122

00:13:43,240 --> 00:13:50,240

We had the hog fence stacked, probably as high as that there.

123

00:13:51,240 --> 00:13:53,240

And we had a solid roof up on top.

124

00:13:54,240 --> 00:13:58,240

And over in that corner was where the panels were being torn off.

125

00:14:00,240 --> 00:14:02,240

This was the corrugated tin.

126

00:14:03,240 --> 00:14:05,240

We had cover on the horse corral.

127

00:14:06,240 --> 00:14:07,240

We can't rip it, you know.

128

00:14:07,240 --> 00:14:09,240

It's like torn, you know, like paper.

129

00:14:10,240 --> 00:14:13,240

He even ripped all these ones. He broke all these.

130

00:14:14,240 --> 00:14:15,240

This is some heavy steel.

131

00:14:20,240 --> 00:14:25,240

Brenda came down. She put up cameras around the horse corral.

132

00:14:26,240 --> 00:14:41,240

There's a suing wet that hits the side of the corral and you just see this tall figure standing there.

133

00:14:42,240 --> 00:14:45,240

We didn't know what it was and that really scared us.

134

00:14:47,240 --> 00:14:54,240

I want the people to be aware of what's out there and to be really careful because we don't know what these things are capable of doing.

135

00:14:56,240 --> 00:15:03,240

During one of our investigations, we started tracking bigfoot for miles.

136

00:15:04,240 --> 00:15:10,240

The footprint just stopped almost like it was just jerked into the sky.

137

00:15:11,240 --> 00:15:18,240

A lot of people believe that bigfoot has some kind of spiritual powers or something where they can just disappear.

138

00:15:18,240 --> 00:15:26,240

They'll tell me, yeah, I seen a bigfoot. I was watching it. I was kind of following it. All of a sudden it just disappeared.

139

00:15:33,240 --> 00:15:43,240

When we started getting reports of bigfoot and the reports started increasing, there was a corresponding increase in UFO sightings.

140

00:15:43,240 --> 00:15:59,240

UFO case. This is an area just off highway, rock 4. Apparently on this location where I'm standing, an unidentified object, light source, beamed light from this area.

141

00:16:01,240 --> 00:16:11,240

We suspect that the UFO activity, that they are coming on a pretty regular basis. Most Navos will tell us it's just a normal thing.

142

00:16:13,240 --> 00:16:19,240

This is tall and saw the light. It was radiating through something.

143

00:16:20,240 --> 00:16:26,240

When you first seen it on the straight light, straight across, that was on this side of this hill.

144

00:16:26,240 --> 00:16:34,240

It was really long. It was like, it was probably like that. Everything lasted maybe like 10 seconds.

145

00:16:35,240 --> 00:16:48,240

I have another case. It's not far from here on Thursday. So whether or not they're correlated between the two, which I would think they're somehow related.

146

00:16:49,240 --> 00:16:57,240

When you hear the word paranormal, one of the common phenomenon is what people refer to as an orb.

147

00:16:58,240 --> 00:17:06,240

And orbs come in all different shapes and sizes and colors and behaviors.

148

00:17:08,240 --> 00:17:14,240

They operate at speeds and angles that we couldn't even hope to duplicate.

149

00:17:18,240 --> 00:17:27,240

We had a case involving a young woman who is working in Flagstaff. So she drives home back to the reservation every night.

150

00:17:28,240 --> 00:17:37,240

I would like to stay anonymous because a lot of people tend to think you're crazy or to not believe in the experience you had.

151

00:17:37,240 --> 00:17:53,240

I was born and raised on the Navajo Reservation. There had been instances where strange lights had been seen in the sky enough that it was known in the community.

152

00:17:54,240 --> 00:18:09,240

As I'm driving home from work, it's about 1.30 in the morning. There are no houses, no lights, no other vehicles on the road. It's open desert.

153

00:18:10,240 --> 00:18:25,240

I noticed a red light off to my driver's side and it followed me for maybe a minute or two. It never emitted a sound of any kind.

154

00:18:26,240 --> 00:18:35,240

I reached a point on the road where it made a sharp curve, so I had to take my eyes off this red ball.

155

00:18:35,240 --> 00:18:44,240

I looked to my left and there is now this big ball and it was a bright white light. It was no longer red.

156

00:18:45,240 --> 00:19:04,240

I was afraid because it was very, very close to me. I didn't know what to do. I realized whatever this was, it was clearly intelligent enough to follow me. It was strange.

157

00:19:05,240 --> 00:19:21,240

It stayed beside me for maybe a quarter mile before it shot forward. Less than 500 feet in front of me, it stopped instantaneously and then shot straight up in the sky.

158

00:19:22,240 --> 00:19:37,240

Once it went up in the sky, it arched across the sky and it looked like a shooting star. It was so terrifying. I didn't want to see it again.

159

00:19:38,240 --> 00:19:53,240

In the morning when I woke up, I had the worst migraine I've ever had. Up to that point, I had never experienced a migraine in my life.

160

00:19:53,240 --> 00:20:02,240

She reached out to me because I live in the same community and she knew I handled these type of cases. I could tell it shook her up quite a bit.

161

00:20:03,240 --> 00:20:11,240

We went around her vehicle with a compass and we were looking for magnetic anomalies.

162

00:20:15,240 --> 00:20:31,240

What we found is two areas that had intense magnetic attraction. One was just behind the driver's door on the panel and the other one was just in front of the passenger door.

163

00:20:32,240 --> 00:20:39,240

If you took a string and tied it between both points, the string went right through the driver.

164

00:20:39,240 --> 00:20:55,240

So we think that when this thing was flying alongside the vehicle, it must have been scanning or doing something to that vehicle that went through her and may have caused a physical result.

165

00:21:03,240 --> 00:21:13,240

For those people that have those first-hand experiences with the supernatural or these paranormal phenomenon, it's something they're never going to forget.

166

00:21:16,240 --> 00:21:28,240

We investigated many, many UFO sightings, but one of the more fascinating cases occurred with a non-navajo resident of the reservation living near Greasewood.

167

00:21:33,240 --> 00:21:47,240

I spent probably about ten years of my life on the Navajo reservation, taught English as a second language.

168

00:21:47,240 --> 00:21:52,240

So I've been living in lower Greasewood for about a year.

169

00:21:53,240 --> 00:22:04,240

Satan's Butte was in the distance. I saw it every single day. It's a flat, top mesa. It's pretty barren. There's no trees.

170

00:22:10,240 --> 00:22:14,240

Every night I would have to go out and I would feed the horses, of course.

171

00:22:15,240 --> 00:22:23,240

One night, just as the sun was going down just at dusk, just this odd light in the sky caught my attention.

172

00:22:25,240 --> 00:22:35,240

I just couldn't figure out what it was. A couple nights later, I see this odd light in the sky hovering above Satan's Butte.

173

00:22:36,240 --> 00:22:39,240

Very, very close to where it was hovering a couple nights before.

174

00:22:40,240 --> 00:22:45,240

It came straight across here and it dipped down.

175

00:22:45,240 --> 00:22:46,240

On this side?

176

00:22:46,240 --> 00:22:56,240

On this side, yeah. It has red lights. I don't know if they go around the back, but it goes like this. You can see them kind of diminishing.

177

00:22:57,240 --> 00:23:13,240

What I saw was a large ship and then coming out of that are these tendrils of light, but they look like teardrops as they drop to the earth.

178

00:23:14,240 --> 00:23:26,240

The light was coming from inside of the ship and the tendrils, I don't know if those are little UFO ships, but they were glowing.

179

00:23:29,240 --> 00:23:38,240

Fast forward a week. I see it again. I thought, I've got to get a picture of this because that would be so cool.

180

00:23:44,240 --> 00:23:51,240

In the photographs that John and I were shown, there was definitely something there.

181

00:23:51,240 --> 00:24:00,240

There's enough evidence from what he gave us and the incidents that he had that are just outstanding from an investigator standpoint.

182

00:24:00,240 --> 00:24:07,240

Any Navajo that I talked to about it, none of them were shocked. Everyone was like, oh yeah.

183

00:24:08,240 --> 00:24:17,240

I didn't think aliens existed. I didn't think that there were UFOs. So I was very, very skeptical.

184

00:24:17,240 --> 00:24:24,240

But the Navajo Nation taught me that there are things out there that we don't understand.

185

00:24:25,240 --> 00:24:35,240

When it comes to the paranormal or supernatural, that element is already within the culture of the Navajo.

186

00:24:35,240 --> 00:24:46,240

The Navajos themselves as a people have a lot of stories that go from generation to generation about paranormal activity.

187

00:24:47,240 --> 00:25:01,240

If you look at pictographs and petroglyphs on the walls and red rock canyons, you see these images that are thousands of years old.

188

00:25:01,240 --> 00:25:12,240

And you see images of UFOs. Is this what is referred to as star people and extraterrestrial beings?

189

00:25:12,240 --> 00:25:20,240

There's a lot of stuff that happens, but none of it is talked about because there's such a stigma.

190

00:25:24,240 --> 00:25:33,240

With the older generations, they still have those traditional teachings of things that are taboo that you don't talk about.

191

00:25:33,240 --> 00:25:45,240

Because the younger generations aren't learning those traditions as much, then they're more open to experiencing these kind of things and sharing the information.

192

00:25:46,240 --> 00:26:03,240

One of the most terrifying type of case that we've investigated involves the legendary Navajo skinwalker.

193

00:26:04,240 --> 00:26:10,240

Most Navajos have heard the term skinwalker.

194

00:26:10,240 --> 00:26:18,240

An entity that can shape shift or change form from a human form into that of an animal.

195

00:26:21,240 --> 00:26:29,240

They can change shape into a coyote, into a wolf, into anything that they have the skin of.

196

00:26:30,240 --> 00:26:37,240

I've had people tell me that they've seen them on the sides of the roads when they were in human form.

197

00:26:37,240 --> 00:26:45,240

And they're painted white. Kind of like if you took a sponge and dipped it in white paint and just blotch it all over your body.

198

00:26:45,240 --> 00:26:51,240

And the paint's cracking. And even the hair is long and painted.

199

00:26:51,240 --> 00:26:55,240

They say that they can run as fast as a car can drive.

200

00:26:56,240 --> 00:27:03,240

These things are dangerous and it's frightening.

201

00:27:07,240 --> 00:27:13,240

I know that these skinwalkers exist because I've experienced it myself.

202

00:27:13,240 --> 00:27:23,240

Prior to my law enforcement career, I had come to the Navajo Reservation.

203

00:27:23,240 --> 00:27:31,240

And at the time I was living near for defiance, I borrowed my older sister's car and went to the movies one night.

204

00:27:32,240 --> 00:27:43,240

And it was on this route when I had something that was running alongside my vehicle on the inside of this fence behind us.

205

00:27:43,240 --> 00:27:50,240

It jumps the fence and it begins getting within three or four feet of the passenger side of my car.

206

00:27:50,240 --> 00:27:56,240

And it was keeping up with me at highway speed. I'm at least 55 miles an hour.

207

00:27:57,240 --> 00:28:01,240

The more that I accelerated, the more it was right there with me.

208

00:28:04,240 --> 00:28:10,240

This thing had the body of like a greyhound, but it was from head to toe, solid white.

209

00:28:10,240 --> 00:28:15,240

The back of it was at least coming up over the side of the door.

210

00:28:15,240 --> 00:28:21,240

It had a mouthful of teeth. It had a head that was canine shaped and it had a long snout.

211

00:28:22,240 --> 00:28:29,240

I locked eyes with it and its eyes were like it was self-illuminating.

212

00:28:29,240 --> 00:28:34,240

A fiery orange, it was like it was looking straight through me.

213

00:28:35,240 --> 00:28:44,240

I just floored it. I came sliding into the driveway, jumped out, ran inside and my father was still awake.

214

00:28:44,240 --> 00:28:51,240

And I explained what I had seen and that's when he said that's a skin walker.

215

00:28:55,240 --> 00:29:03,240

To see it with your own eyes and to know that it wasn't make-believe, that it wasn't fantasy, it wasn't legend,

216

00:29:03,240 --> 00:29:10,240

this was in its actual running on all fours form.

217

00:29:10,240 --> 00:29:17,240

That was one of those moments where I realized that these things are very real.

218

00:29:18,240 --> 00:29:23,240

My aunt sought help from a medicine man.

219

00:29:23,240 --> 00:29:36,240

The medicine man said me seeing that thing running by the car wasn't some way tied to somebody out there trying to do our family harm.

220

00:29:37,240 --> 00:29:44,240

The only reason that people do the shape-shifting thing is to harm others.

221

00:29:45,240 --> 00:29:49,240

They want to do harm. They definitely want to do harm.

222

00:29:52,240 --> 00:29:58,240

In my experience in 31 years out there, I can guarantee you that this is real.

223
