Leigh was very polite, but also very annoying, with many trivial messages. He was what I call a "high maintenance client," and I stopped responding to him after the first few exchanges. On 10/15, I questioned him about his credentials. After that, the volume of his email increased, with little response from me.

I am usually uncomfortable about publishing private email without permission, but Mr. Leigh is going away for a long time, and his email contains enough obvious lies that the courtesy of confidentiality isn't merited.

I am very glad to have found you, as I have certainly heard of you and had seen you once when I was in the hospital on a Larry King show--Live--out in the desert near a.k.a., "Area 51." I am a former Navy SEAL, Honorably Discharged, Disabled Veteran, having 5 spinal-fusion operations over the past 12 years. I mention this, that you may know that I have never taken a computer course, nor a typing course, much to my disliking. I just wanted you to know that Medical difficulties and computer dumbfoundness have kept me from contacting you, also, I answer ALL of my e-mails--which were over 1MB (1,118) after the Roswell 50th Fest-97. Yes, we were there to give interviews and to meet with our new found friends there.

I would much enjoy hearing from you, "Desert Rat," as I would be very proud to know you.

I taped "The History Channel" the other night, when you were on it, with of course, the others at the Roswell Fest.
It seemed to have been a Canadian Production, as I recall the credits.

You did a fine interview (this, from a former Director in TV-News and Production with PBS:)), and stated some OBJECTIVE points of view, which

Down towards what would have been the bottom of the joining of these two arches--on the inside area--was a circular, inner object, which had a darkened area in the direct center, as in a "bull's-eye" on a target. This was confirmed by using my 8 x 24 small field glasses, which I keep in the glove box. This circular inner object remained stationary, as did the 'arches,' and had the appearance of being a solid, metallic orb, with as mentioned above: a darkened area at the very center. Since the sun was directly behind this object: the center object did not reflect light. I based this observation from what I had observed with my naked-eyes and looking through the field glasses.

There was to the direct SSW, an AWAX 747 jet, flying very low (about 2,000 ft.), on an easterly, horizontal course, seemingly, in pursuit of the anomalous object, when upon leveling off from what would have been a 180 degree turn for this 747 AWAX jet, coming first from the south--heading north--then looping back around 90 degrees towards the object in the east from its perspective: the AWAX 747 looped 90 degrees again towards the SSW and away from the object--in dramatic fashion--as if the 747 had seen enough--and wanted to evade this area of the sky--in a hurry--detracting from how large 747's usually maneuver.

Total viewing time: about one (1) minute, when the three (3) objects-in-one, suddenly became half of its original size--then vanished--in an instant, not dissipating at all; but vanishing--all together . . .

Conclusion: This could not have been two fighter-jets flying straight up and then curve around to form the two 'arches,' as they would have been flying so low--that sonic-booms would have been heard all over that area, and having worked for NASA in the Space Shuttle Project: not even the Shuttle can launch straight up defying gravity, as they must make a yaw, or, a slight turn to compensate for the inertia. Not even missiles can go straight up, being victim of gravity as well.

Although, admittedly, the 'arches' did have the appearance of some form of a 'vapor-trail,' this too could have been an effect of atmosphere from the appearance and energy of this "apparition," or, maybe, it was a "masking" effect from a UFO? But since there was not a trace of this 'vapor-trail' when the object (as a whole) disappeared: rule-out any known, horizontal-flying aircraft. The departure speed alone would rule-out airplanes, or jets, as well.

I, therefore, conclude as an honest man, that this object was indeed what I have said that it was, as my wife (who was driving) saw it, AND the AWAX jet, too: an "apparition," or a 'cloaking,' UFO
