Mr. Gersten has lost the focus of my post. Let me repeat again: the FEAR of arrest and DRACONIAN punishment is enough to deter government witnesses from violating their national security oaths and testifying to Congress on their experience of UFO/ET reality, UNLESS they receive immunity from prosecution. <
