MUFON does not tend to become so back logged because of its pyrimad stucture and our large number of investigators under that structure.

John Timmerman is only responsible to MUFON for his small section of Ohio. The fact that he has collected a lot of cases in his travels is interesting but not unusual. Like John we all hear about cases, especially when we are on the road, and we do not always get back to them when we return to our work-a- day lives.
